A special meeting between the City of Ketchum and Visit Sun Valley to discuss issues identified below and any other issues associated with the budget and work performed by Visit Sun Valley.

1. Marketing Strategy
 - a. Who determines the marketing strategy
 - b. Who does the creative work to implement the marketing strategy.
 - c. Why is digital better than print or other mediums. What process is in place to evaluate and determine the best method for placement.
 - d. What is the present marketing campaign for this year, has one been developed for next year.
2. Working Relationships
 - a. What services or marketing is provided for local businesses by VSV.
 - b. How does the visitor center operate, how does a business get placement there, and what is the long range strategy for operating the center.
 - c. How does VSV interact with the State Tourism Board. What is VSV doing to compete for State funding generated from Region 7, why is there no Region 7 Travel Organization and what collaboration is taking place among all the Region 7 cities.
 - d. Sun Valley Resort—what is their role in developing the marketing strategy, what funding do they provide, what role do they play with VSV.
3. Budget
 - a. Break down of budget, overall expenditures and itemize how the city funding (450k and 1% LOT funding) is specifically being spent.
4. Events
 - a. What is the event strategy VSV is following, who decides what events get in-kind or direct marketing support.
 - b. What events are being supported with in-kind, direct funding or marketing efforts.
 - c. What is the amount of funding or in-kind support for the events supported by VSV.
