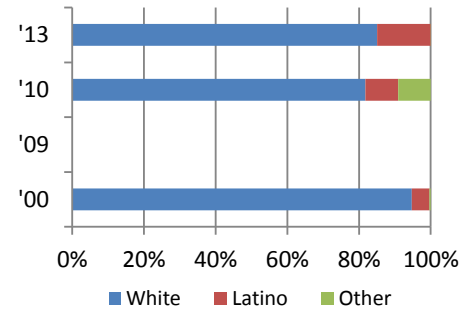

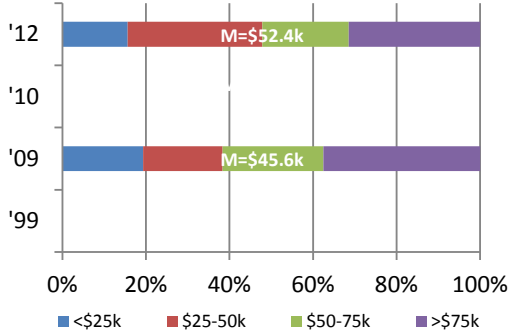

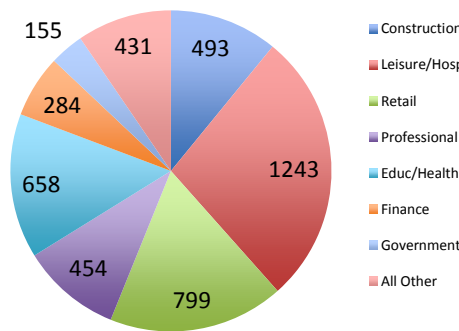

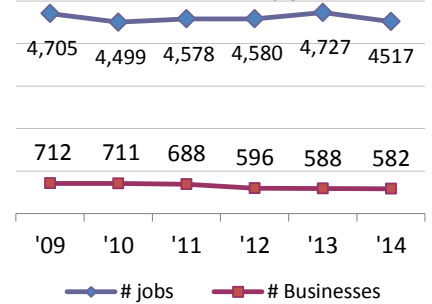
Household Income Distribution

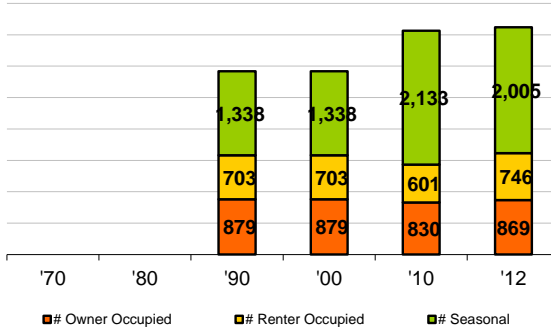

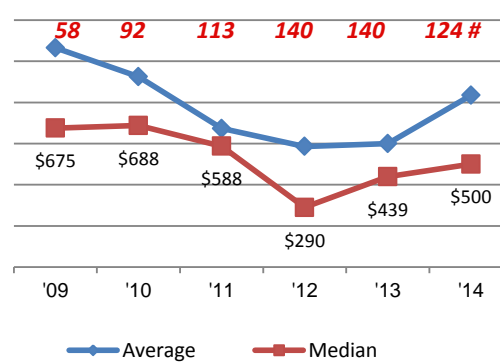

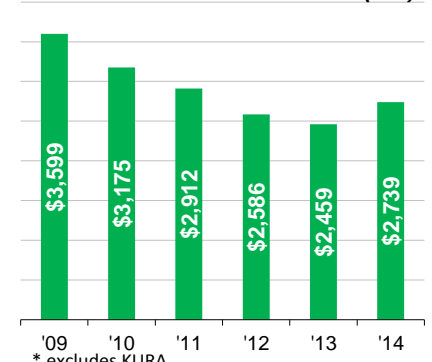
Housing Stock Utilization(# units)

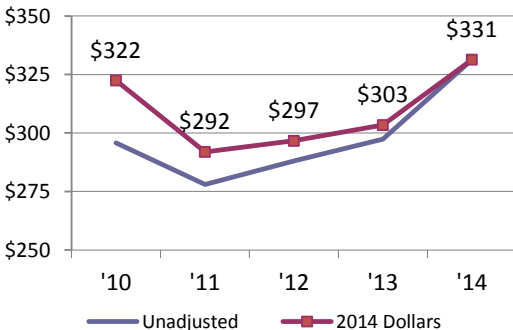

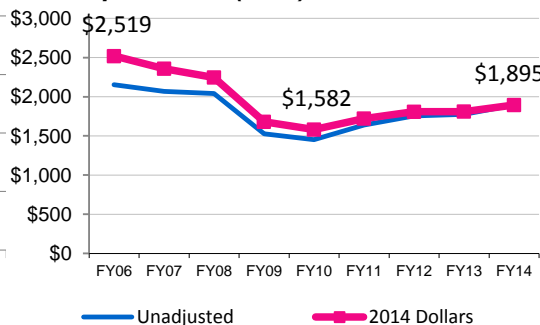

Local Options Tax (\$000)

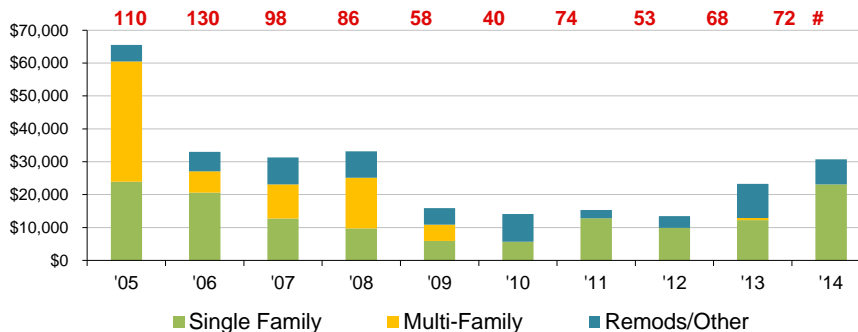


Business License Changes (#cummm)

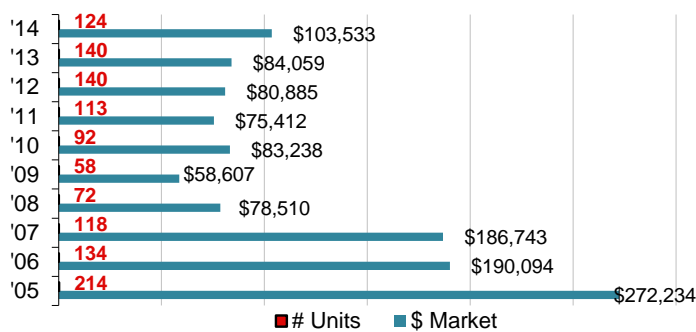

Residential Building Permits (\$000 & #)

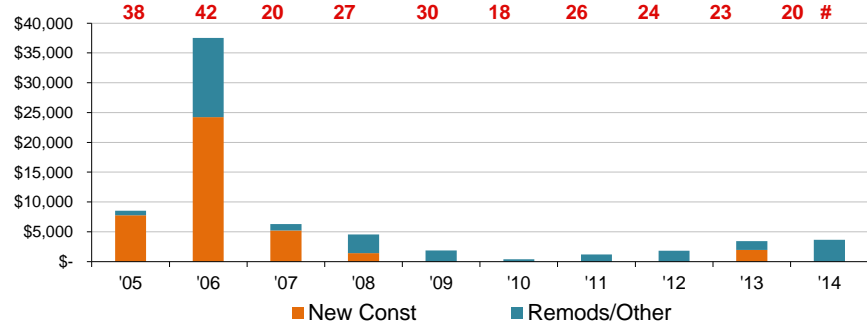


Residential Sales Transactions (\$000 & #)

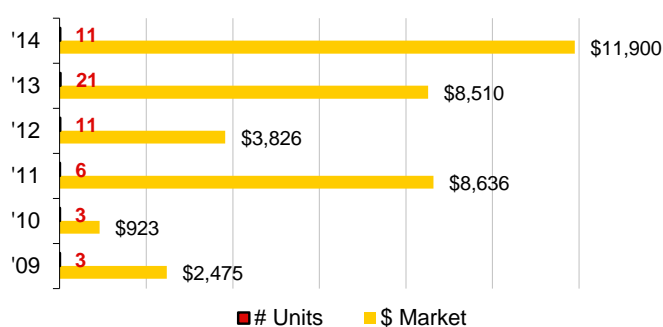


CITY COMMERCIAL ACTIVITY

Commercial Building Permits (\$000 & #)

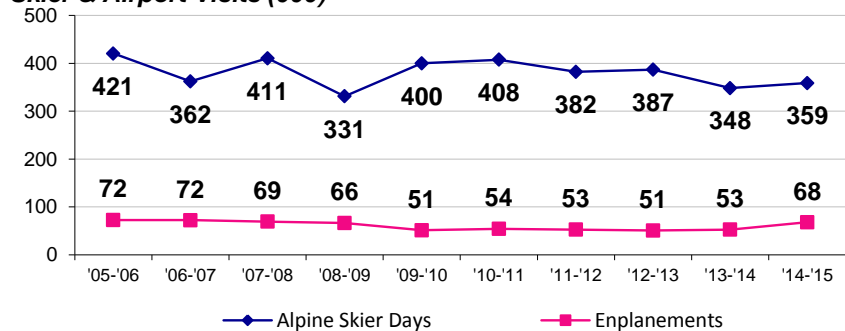


Commercial Sales Transactions (\$000 & #)

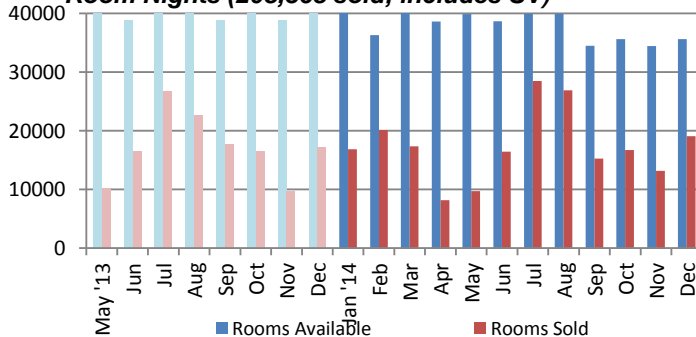

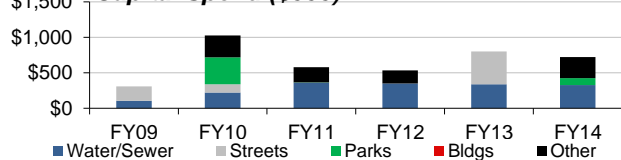
