The Planning and Zoning Commission, a Code Work Group, and Staff have been working together to evaluate and propose changes to two sections of code regarding the Commercial Core District. The current code poses specific impediments to the kind of development the Ketchum Comprehensive Plan, Downtown Master Plan and the zoning code itself anticipates. The proposed changes would remove impediments and clarify the incentives regarding increased floor area ratios and community housing. The City Council conducted a public hearing and approved the first reading of Ordinance Number 1117 at their meeting of May 19, 2014. Joyce Allgaier, Director of Planning and Building has provided a detailed staff report and the Ordinance in the packet for Council review.

RECOMMENDATION: Staff respectfully recommends the Council waive the second and third readings and adopt the ordinance.

Resolution No. 14-014, Appointment a Member to the Planning and Zoning Commission

Introduction/History

The appointment of Planning and Zoning Commission members is the responsibility of the Mayor with confirmation by a majority vote of the City Council. According to its bylaws, Ketchum's Commission consists of five (5) members and up to two (2) of those members may reside outside of the city limits. There is no requirement for Ketchum to have representation by members who live within the Area of City Impact as is the case in some communities. Commission members must have resided in Blaine County for at least 3 years in order to be considered.

Planning and Zoning Commissioners serve for three-year appointments and may serve for two terms, with the statutory provision that allows for additional terms as long as the appointment is confirmed by a 2/3 vote of the council.

Current Report

Staff placed an advertisement in the Mountain Express for three (3) Wednesday editions announcing the opportunity for involvement on the Commission. Letters of interest were due to the City on April 7, 2014.

In discussions with Mayor Jonas, she indicated that she would contact candidates and make a recommendation at the City Council meeting.

Financial Requirement/Impact

The City of Ketchum provides compensation for Planning and Zoning Commission members for their time and expertise at a rate of \$150.00 per meeting. This expenditure is planned for in the annual Community and Economic Development Department budget and has been appropriated in the FY 2013/14 City Budget.



A financial commitment of \$10,000 was allocated towards this contract for services in the 2013/2014 Ketchum municipal budget.

Mayor Jonas and City Councilors:





Many efforts have been undertaken over the years to make Ketchum a bicycle and pedestrian friendly place for residents and visitors alike - from the monumental installation of the Wood River Bike Path to the redesign of the 4th Street Heritage Corridor in 2008 and the most recent "Walkable Ketchum" improvements. Ongoing refinements and upgrades are needed to ensure that the system performs well as our community core becomes busier and more popular as a place to be. The community core, with its attractions of the Town Square, Atkinson's Market, events and retail options has placed a great deal of demand on our streets and sidewalks. This high demand and use by vehicles, cyclists and pedestrians can sometimes be in conflict and reinforces the fact that we must ensure our public ways are safe, efficient and high-It is to this end that Mayor Jonas, working with staff and the Traffic Authority, has identified areas where refinements to our sidewalk, street, and bike way infrastructure would be beneficial. It should also be noted that a core focus of this initiative is to reinforce the original intent of the 4th Street improvements - to create a safe bike and pedestrian friendly way that is not dominated by cars, and that serves as a connection to the city's bike ways and important activity areas on both sides of Main Street.


Current Report

This report will serve to identify key improvements and actions that are being contemplated through the 2014 Bicycle and Pedestrian Friendly Initiative. This report is also intended to be an update in order to raise public awareness as well as to engage the council in discussion. Following is a list and brief narrative about the strategy or action, along with its status.

4th Street and Main Street:

 Install portable seasonal (summer time) signs along the centerline (1 or 2 per block). This strategy is intended to accomplish several things. 1.) Call the 4th Street out






as Ketchum's Ped/Bikeway, acknowledging that bikes and pedestrians will be present and vehicles must share the road, 2.) Serve as a traffic calming device because a more focused and slower rate of travel will be required when signs are present at the centerline, and 3.) Suggest to cars that they only use 4th Street to travel one block, then move to other streets when possible. No parking will be removed or changed. We hope that by calling out this ped/bikeway more clearly, that cyclists will feel more comfortable using 4th Street and free up sidewalks for pedestrians. 4th Street gets very congested in the peak summer season and it serves as the main connection to the Sun Valley-Ketchum bike lane. (Status: Project to be installed in June. Consideration is being given to the messaging of the sign to ensure clarity. Council comment is desirable.)

Paint diagonal crosswalk at 4th and East intersection. This allows for pedestrians to




cross the street diagonally in a partially-delineated crosswalk lane. (According to the adopted MUTCD). In essence this allows for quicker and safer crossing to get to high use areas like Atkinson's, Town Square, Big Wood Bakery, etc. allowing the pedestrian to cut across or "legally J-walk" the intersection. (Status: Completed.)


• Install a flashing pedestrian (on-demand push activated) crossing light at 4th and Main. This project would allow pedestrians to activate a yellow flashing light to assist in crossing Main Street. An evaluation is underway to determine the proper location for the two light poles (on the south or north corners of the intersection). Again, this would help build connectivity to the "West of Main" (WOMA) area of Ketchum's downtown and reinforce the initial intent of the 4th Street improvements. (Status: Project under evaluation. Project cost \$10k. Council input is desirable as to support.)



Right turn in and right turn out only. Movements from 4th Street and Main would be restricted to right turn onto 4th only from Main, and right turn only from 4th onto Main. This would encourage use of the signalized intersections on Main Street, and discourage left turns and straight thru driving movements on 4th Street. Signs and/or a chicane would be used to advise the driver. (Status: Under evaluation and council input is desirable.)



Paint "sharrows' on 4th Street.



Sharrows designate that a travel way is expected to be used by both bikes <u>and</u> cars. (To be completed this spring with city-wide street striping project.) (Sharrows will also be painted on 1st Avenue to connect the bike path in that part of the city.)

Spruce Street Bike Lane Painting:

 A full green bike lane will be painted along the northeasterly side of Spruce Street connecting the Sun Valley Road bike path with 4th Street. This will provide clarity to cyclists that a designated lane is available to them and leads to the 4th Street Ped Bikeway. (Status: To be accomplished with all street painting this spring.)

Bike Parking Corrals:

• Three bike parking corrals in the public right of way are proposed for installation to create designated on-street bike parking areas in high use parts of the downtown core. Each bike rack will accommodate 10 bikes and be clearly marked as bike parking. The goal of this strategy is to confirm to cyclists that Ketchum values bikes in our community by providing a protected and designated area to park in the right of way, just as cars do. One corral is slated for Walnut Street at the end of the center aisle parking in front of Velocio. This will help relieve the high level of sidewalk bike parking that is often found at Velocio and the Gold Mine. Jack Bariteau has offered to partner with the city to install a bike rack with protective side rails. Another corral

would be located on East Ave. at 4th Street intersection in front of the Big Wood Bread Café in a no car parking triangle. The third corral would be located on East Ave. and 4th Street intersection on the Town Square side of East Ave. and close to Leroys. Again, this corral would be located in a no car parking triangle. (Status: To be installed this spring. Bike racks have been purchased.)

<u>Public Bike Share Project with Mountain Rides</u> – Discussions are underway with Mountain Rides to locate 3-4 "bike share" stations in the city. This program would create a membership and pay-as-you-go system for bike use.

<u>Community Choices for Idaho Grant Program</u> – The city has been nominated for final approval for two grants slated for sidewalk improvement and infill. Finalization of this grant money by the Idaho Transportation Board could come within 3 weeks. If finalized, approximately \$227,000 could be awarded to the city over the course of 3 years. This money will help us improve walkability through design and the upgrade of existing and construction of new sidewalks in the community core.

Financial Requirement/Impact

Ongoing operational costs include maintenance of improvements, restriping, painting and sign production/replacement. The estimated cost of installing a pedestrian activated light at the intersection of 4th Street and Main Street is \$10,000. Staff requests that the council weigh in on the desirability of the improvement and budget expenditure.

Recommendation

Review, discuss and provide comment for staff implementation of these strategies. These recommendations are made through the cooperative work of Mayor Jonas, Councilperson and Traffic Authority member, Michael David, Robyn Mattison, Public Works Director/City Engineer, Brian Christiansen, Streets Superintendent, Juerg Stauffacher, Parks and Natural Resources Superintendent, David Kasner, Assistant Police Chief, and Steve Harkins, former Police Chief.

Mayor Jonas and City Councilors:

Discussion Regarding Location for Potential Short Term RV/Trailer Parking

Introduction/History

Recently there has been some discussion regarding providing a convenient location for short-term (daytime only) RV or trailer parking in the City. The intent is to provide easy access parking for RVs or trailers so that owners may enjoy the amenities of the City without having to struggle with downtown parking.

Current Report

Two potential locations that have been discussed so far include A) the parking lot at River Run at Serenade Lane and Cottonwood St/3rd Avenue and B) the center street parking on 1st Avenue between River Street and 6th Street. A figure showing the location on 1st Avenue is attached.

Signage would be provided on Main Street to direct RV traffic to the designated location. On 1st Avenue signage would also be provided to designate an area for RV/Trailer parking only.

A) River Run Location

Pros:

- Ample parking available
- Easy access in/out
- Located on existing Mt. Rides route

Cons:

- Lot is SV Co. property authorization required
 - SV Co. has concerns but would be willing to listen to thoughts if a plan (i.e timing, signage, etc.) were proposed
- Lot is far from downtown core ideal only if Mt. Rides could provide regular service to/from the lot.
 - Mt. Rides 2014 summer schedule is already planned and budgeted.
 - Red Route will run from June 14th through Labor Day. This route will provide transportation to/from the River

Run area into downtown Ketchum on an hourly basis between 8:25am and 4:55pm.

 Potential to increase service or adjust existing service for future seasons.

B) 1st Avenue Location Center parking from River Street to 6th Street, or a portion thereof.

Pros:

- City ROW no authorization required
- Easy walking distance to downtown core

Cons:

- Access not as easy for RVs as River Run
- Designated RV parking only signs will reduce other parking



SUN VALLEY EVENTS, INC. AGREEMENT

THIS CONTRACT FOR SERVICES ("Agreement") is entered into effective as of ______by and between Sun Valley Events, Inc. and the City of Ketchum, an Idaho municipal corporation (Sun Valley Events, Inc. and City of Ketchum are, collectively, the "Parties") with reference to the following facts:

RECITALS

- A. The City of Ketchum desires to promote business by enhancing the visitor and resident experience in the Ketchum/Sun Valley area with the Ketchum Wagon Days event ("Wagon Days").
- B. Sun Valley Events, Inc. has the expertise necessary to promote, organize, manage, coordinate and produce Wagon Days and other related programs and to assist the City of Ketchum in the management of Wagon Days from June 1, 2014 to October 1, 2014 ("Contract Period").
- C. City of Ketchum desires to retain the services Sun Valley Events, Inc., and Sun Valley Events, Inc. desires to provide the services, as set forth herein.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Parties agree as follows:

- 1. <u>General Duties</u>. Sun Valley Events, Inc. agrees to promote, organize, manage, coordinate and produce Wagon Days according to the terms and conditions of this Agreement.
- 2. <u>Description of Services</u>. Sun Valley Events, Inc. shall complete the tasks on the schedule as outlined in Addendum 1 attached hereto and incorporated herein by this reference (the "Services").
- 3. **Payment for Services.** In exchange for the Services, City of Ketchum shall pay Sun Valley Events, Inc. as follows:

<u>Professional service fee</u> – The \$25,000 contract amount will be paid in four installments on the fifteenth day of each month beginning June 1 until October 1, 2014. Payment shall be made based on Ketchum review and approval of work completed that month.

4. <u>Term – Month to Month.</u> This Agreement shall be effective for a period of one month and shall renew automatically each month and expire automatically on October 1, 2014 unless terminated as provided herein. The parties hereby agree that in the event Ketchum, in its sole and exclusive opinion, lacks sufficient funds to continue paying for the Services, Ketchum may terminate this Contract without penalty upon thirty (30) days written notice to Sun Valley Events, Inc. Upon receipt of such notice neither party shall have any further obligation to the other. In the event of such termination, Sun Valley Events, Inc. shall submit a report of expenditures to the City of Ketchum. Any Ketchum funds not

encumbered for authorized expenditures by Sun Valley Events, Inc. at the date of termination shall be refunded to Ketchum within twenty (20) days.

5. <u>Independent Contract/No Partnerships or Employee Relationship.</u>

- (a) By executing this Agreement, the Parties do not intend to create a partnership, joint venture, agency employee/employer relationship or any other relationship other than that of Independent Contractor. Neither Party shall have the power to bind the other in any manner whatsoever.
- (b) In rendering the services contemplated by this Agreement, Sun Valley Events, Inc. is at all times acting as an Independent Contractor and not as an employee of City of Ketchum. Sun Valley Events, Inc. shall have no rights or obligations as an employee by reason of the Agreement, and City of Ketchum shall not provide Sun Valley Events, Inc. with any employee benefits, including without limitation, any City of Ketchum sponsored retirement, vacation or health insurance program.
- (c) Except as set forth in the Addenda to this Agreement, City of Ketchum shall not exercise any control whatsoever over the manner in which the Sun Valley Events, Inc. performs the obligations contemplated herein.
- (d) Sun Valley Events, Inc. may perform services similar in nature to the services contemplated in this Agreement for other individuals and entities during the term of this Agreement.
- (e) City of Ketchum shall not withhold any local, state, or federal payroll or employment taxes of any kind from any compensation paid to Sun Valley Events, Inc. Sun Valley Events, Inc. hereby warrants and represents that it will pay all such employment and payroll taxes, if any, and hereby releases, holds harmless and indemnifies City of Ketchum and the directors, officers, members, employees and agents thereof from any and all costs, expenses or liability of any kind whatsoever that may be incurred as a result of Sun Valley Events, Inc.'s failure to pay such payroll or employment taxes.
- 6. <u>Assignmen</u>t. Neither Party shall assign any of its rights and/or obligations under this Agreement to any other person or entity.
- 7. **Representations and Warranties by Sun Valley Events, Inc.** Sun Valley Events, Inc. hereby represents and warrants to City of Ketchum as follows:
- (a) Sun Valley Events, Inc. has the knowledge, experience and expertise and office equipment resources necessary to promote, organize, manage, coordinate and produce Wagon Days.
- (b) City of Ketchum shall retain proprietary rights over all Wagon Days electronic and physical records and files, mailing lists, ideas, contracts and other items relating to the event.
- (c) Public Records. Sun Valley Events, Inc. hereby acknowledges that all writings and documents, including without limitation email, containing information relating to the conduct or administration of the public's business prepared by Sun Valley Events, Inc. for Ketchum, regardless of physical form or characteristics may be public records pursuant to Idaho Code Section 9-337 *et seq*. Sun Valley Events, Inc. further acknowledges that, subject to certain limitations, the public may examine and

take a copy of all such public writings and records. Accordingly, Sun Valley Events, Inc. shall maintain such writings and records in such a manner that they may readily identified, retrieved and made available for such inspection and copying.

- (d) Sun Valley Events, Inc. shall provide all Wagon Days materials to City of Ketchum immediately upon request.
- (e) Sun Valley Events maintains no control over the personnel, equipment or operation of any airline, surface carrier, bus or limousine company, transportation company, hotel, restaurant, venue, audiovisual, staging, lighting, décor, entertainment or other person, corporation or other entity furnishing services or products connected to the event and that all such suppliers are independent contractors.
- 8. **<u>Default.</u>** In the event either Party hereto defaults in its performance of any of the obligations created hereunder, the other Party may pursue any and all remedies whether at law or equity, including without limitation terminating this Agreement.
- 9. <u>Voluntary Agreement</u>. This Agreement is freely and voluntarily entered into by each of the Parties. The Parties acknowledge and agree that each has been represented in the negotiation of this Agreement by counsel of its own choosing or has had an opportunity and ability to obtain such representation, that it has read this Agreement or had it read to it, that it understands this Agreement, and that it is fully aware of the contents and legal effects of this Agreement.
- 10. <u>Binding Agreement</u>. The provisions of this Agreement shall be binding upon, and shall obligate, extend to, and inure to the benefit of, each of the legal successors, assigns, transferees, grantees, and heirs of each of the Parties, and all persons who may assume any or all of the above-described capacities subsequent to the execution of this Agreement.
- 11. <u>Meditation</u>. Should a dispute arise and is not resolved by the Parties, the Parties shall first proceed in good faith to submit the matter to non-binding mediation with a mediator licensed in the State of Idaho. Upon completion of one attempt at mediation, either party may pursue any available legal or equitable remedy.
- 12. <u>Attorneys' Fees and Costs</u>. In the event that any of the Parties is required to incur attorneys' fees and/or costs to enforce or interpret any provision of this Agreement or is required to defend any action brought by any of the Parties, based on, arising from or related to this Agreement, the unsuccessful Parties agree to pay to the prevailing Parties their reasonable actual costs and attorneys fees, whether or not litigation is actually commenced and including reasonable attorney fees and costs on appeal.
- 13. **Entire Agreement.** This Agreement contains the final, complete, exclusive, and entire agreement and understanding between the Parties on this topic and supersedes and/or replaces any and all prior negotiations, proposed agreements, and agreements, whether written or oral on such topic.
- 14. <u>Modification</u>. This Agreement may not be modified except by a writing signed by all Parties

affected by such purported modification.

- 15. <u>Waiver.</u> In the event of any default hereunder by either Party, if the other Party fails or neglects for any reason to demand full performance, such failure or neglect shall not be deemed to be a waiver of the right to demand full performance or a waiver of any cause of action, or as a waiver of any of the covenants, terms or conditions of this Agreement or of the performance thereof. None of the covenants, terms or conditions of this Agreement can be waived by either Party hereto except in a signed writing.
- 16. **Severability.** In the event that any portion of this Agreement is held by a court of competent jurisdiction to be invalid, illegal or unenforceable in any respect, the validity, legality, and enforceability of the remaining portions of this Agreement and the application thereof shall not in any way be affected thereby.

17. **Interpretation.**

- a. Whenever in this Agreement the context may so require, the neuter gender shall be deemed to refer to and include the masculine and the feminine, the singular number shall be deemed to refer to and include the plural, and <u>vice versa</u>.
- b. This Agreement is the result of negotiations, and no Party shall be deemed to have drafted this Agreement for purposes of construing any portion of the Agreement for or against any Party.
- c. The descriptive headings in this Agreement are included for convenience of reference and are not intended to affect the meaning or construction of any of the provisions herein.
- d. Any exhibit attached hereto shall be deemed to have been incorporated herein by this reference as if set forth herein at length.
- 18. **Time is of the Essence**. Time is hereby made expressly of the essence in every term.
- 19. <u>Governing Law and Jurisdiction</u>. This Agreement shall in all respects be interpreted, enforced, and governed by and under the laws of the State of Idaho without giving effect to its conflicts of law provisions. The Parties each expressly agree to the appropriateness of and consent to the venue and jurisdiction of the State of Idaho in the County of Blaine and all state and federal courts having geographical jurisdiction for such County as the exclusive forum for the purposes of any action to enforce or interpret this Agreement.
- 20. <u>Capacity to Execute</u>. Each of the Parties, and each person signing this Agreement, represents and warrants that it and its representative(s) executing this Agreement on its behalf each has the authority and capacity to execute this Agreement.
- 21. <u>Counterparts.</u> The Parties may execute this Agreement, and any modification(s) hereof, in two or more counterparts, which shall, in the aggregate, be signed by all of the Parties. Each counterpart shall be deemed an original instrument as against any Party who has signed it. A faxed copy of the signature of any of the Parties shall have the same force and effect as an original signature of such Party.

22. **Indemnification.** City of Ketchum shall indemnify and hold harmless Sun Valley Events and its directors, agents and employees free, clear and harmless, from and against any and all losses, liabilities, costs, expenses (including amounts paid in settlements and reasonable attorney's fees), claims, penalties, judgments and damages, resulting from or arising out of, by reason of any act, omission or negligence of the City of Ketchum or its respective agents, employees or contractors in any way connected with or arising out of any accident, injury or damage, any breach of representation, injury to person or property, any activity conducted or action taken by Sun Valley Events, directly or indirectly, in conjunction with this Agreement. Sun Valley Events, Inc. shall indemnify and hold harmless Ketchum and its directors, agents and employees free, clear and harmless, from and against any and all losses, liabilities, costs, expenses (including amounts paid in settlements and reasonable attorney's fees), claims, penalties, judgments and damages, resulting from or arising out of, by reason of any act, omission or negligence of Sun Valley Events, Inc. or its respective agents, employees or contractors in any way connected with or arising out of any accident, injury or damage, any breach of representation, injury to person or property, any activity conducted or action taken by the City of Ketchum, directly or indirectly, in conjunction with this Agreement.

Introduction/History

The Planning and Zoning Commission, a Code Work Group, and Staff have been working together over the last three months to evaluate and propose changes to two specific sections of the code having to do with the Commercial Core District. The Code Work Group included people who are knowledgeable of the development arena and work with the Zoning Code - Dick Fenton, David Patrie, Jim McLaughlin, and Commissioners Mike Doty and Steve Cook. Staff has found through our own experience and in working with people like those in our work group and with other design professionals, that the code poses specific impediments to the kind of development the Ketchum Comprehensive Plan, Downtown Master Plan and the zoning code itself anticipates. Our goal was to make some targeted changes that we felt would remove impediments and clarify the incentives regarding increased floor area ratios and community housing.

The Code Work Group conducted several work meetings and the Planning and Zoning Commission conducted a work session and then held a public hearing on the proposed amendments. At their public hearing on April 28, 2014, the commissioners recommended approval of the attached ordinance to the City Council.

The City Council conducted a public hearing on this matter on May 19, 2014, took public testimony, and set the 2nd Reading on Ordinance No. 1117 for June 2, 2014.

BACKGROUND & EXPLANATION

Staff convened a Code Work Group of citizens to evaluate and propose changes to two specific sections of the Ketchum Zoning Code (the "Code") having to do with the Commercial Core District. These people, who work with and are knowledgeable of the Code, include Dick Fenton, David Patrie, Jim McLaughlin, and Commissioners Mike Doty and Steve Cook. Staff has found through our own experience, in working with people like those in our Work Group, and with other design professionals, that the Code poses specific impediments to the kind of development the Ketchum Comprehensive Plan, Downtown Master Plan and the zoning code itself anticipates.

In follow up to questions at the Council's meeting of May 19th, on this matter, at the meeting Staff will provide some information about past codes that related to FAR and community housing.

Attached please find the proposed code amendments that came from the three discussion sessions of the Code Work Group, a work session of the Planning and Zoning Commission and then a public hearing of the Commission. Specifically, the suggested changes come in these areas:

SECTION 17.64.010.C, EXCEPTIONS Provides for the Planning and Zoning Commission to have some flexibility in the review of <u>architectural design elements</u> and standards that are rigid requirements in Section 17.64.010 (L). Exceptions are <u>not</u> proposed to be allowed for basic use and development standards such as allowable land uses, height, setbacks, FAR, or life safety provisions, unless otherwise permitted through other provisions in the zoning code or building code. In Staff's opinion and that of the Code Work Group, the Code includes some unnecessarily prescriptive design requirements that can hamper appropriate design, allow for tailoring of design for certain settings and contexts, and may bring about undesirable design or use of resources. For example, for Building Type 4, Multi-family home, (allowed in Subdistricts C and D), the following requirements exist (<u>underlining</u> provided for emphasis):

B. External chimneys may extend up to 2 feet into the side and rear yard setback zone. External chimneys are prohibited on all facade fronting a street, avenue, park or public plaza.

C. Bay windows may project up to 3 feet from the façade. Bay windows may extend into the front setback zone. Windows <u>shall be required</u> on each side of the bay window.

These are just two examples of unnecessary requirements where greater flexibility is not likely to negatively impact the building, the vicinity or the sense of character of the city.

SECTION 17.64.010.H, MAXIMUM FLOOR AREA RATIO

- 2.a Confirms what portion of the building is used to calculate the amount of required community housing in order to achieve the increased FAR. (20% community housing is required and that 20% measurement is based on the square footage of the building only in excess of the initial 1.0 FAR.) This takes away the penalty for the square footage that comprises the initial 1.0 FAR. (A portion of the old "d" was added to this section to consolidate the provisions related to how the square footage is calculated.)
- 2.b Clarification of the number of stories allowed. The current code language was unclear leading one to think that even a two story building could not attain the FAR incentive. This also reinforces that fourth floors are allowed under specific circumstances provided for in other areas of the code projects that are hotels, PUDs, 100% community housing, etc.
- 2.c Sets the target income category at "Category 4" based on housing guidelines for the housing to be provided and allows for options to Category 4. This allows for a more predictable and calculable expenditure and value for the community housing for design and location purposes.
- Old 2.d Moved above to 2.a
- Old 2.e Deletes the waiver for hotels gaining a building permit by June, 2012, since that date has passed.
- Old 2.f (New e) Discusses that a full housing unit may be allowed or a fee in lieu may be provided and how the fee is calculated.
- Old 2.g (New f) Indicates that housing must meet the standards of the governing housing authority, clarifies its role, and gives city council authority to approve options in the administration of housing.
- Old 2.h (New g and h) Clarifies various options to meet the community housing incentive either outright or by special approval of the city council. It is intended that special circumstances may arise that will need to be evaluated with individual projects. For example, someone may provide a larger unit than required and a credit may exist.

EVALUATION STANDARDS

1. Pursuant to Section 17.152.010 of Zoning Code Title 17, amendments to the zoning ordinance or the zoning map "shall be in accordance with the laws of the State of Idaho and all other applicable City Ordinances".

<u>Staff Analysis:</u> The proposed amendment is in accordance with the laws of the State of Idaho and other applicable City Ordinances. The Council has the right to enact legislation dealing with this issue. Recommendation: This standard will be met through the public hearing process.

2. Idaho's Local Planning Act, Section 67-6511 states that ordinances establishing zoning districts shall be amended as follows; (a) Requests for an amendment to the zoning ordinance shall be submitted to the zoning or planning and zoning commission which shall evaluate the request to determine the extent and nature of the amendment requested.

Particular consideration shall be given to the effects of any proposed zone change upon the delivery of services by any political subdivision providing public services, including school districts, within the planning jurisdiction. (b) If the request is in accordance with the adopted plan, the ... commission may recommend and the governing board may adopt or reject the ordinance amendment under the notice and hearing procedures provided in Section 67-6509, Idaho Code.

<u>Staff Analysis:</u> The proposed code amendments will help to implement the provisions of the 2014 Ketchum Comprehensive Plan and the 2006 Downtown Master Plan by allowing for the following:

- Clarification of the code provisions,
- Allowance for greater density in the commercial core where it is a desirable physical development character,
- Creation of a more vital downtown core area that includes a mixture of uses, and
- Encourages the development of community housing units through the provision of a floor area ratio increase incentive.

No comments have been received from any political subdivisions. <u>Recommendation:</u> This standard will be met.

AN ORDINANCE OF THE CITY OF KETCHUM, IDAHO, AMENDING TITLE 17, CHAPTER 17.64.010, COMMUNITY CORE DISTRICT, (C) EXCEPTIONS, AMENDING LANGUAGE TO ALLOW FOR EXCEPTIONS TO BE ALLOWED BY THE PLANNING AND ZONING COMMISSION IN THE DESIGN REGULATIONS, AND (H) FLOOR AREA RATIO AMENDING LANGUAGE PERTAINING TO ALLOWABLE FLOOR AREA RATIOS AS IT RELATES TO THE COMMUNITY HOUSING INCENTIVE AND; PROVIDING A SAVINGS AND SEVERABILITY CLAUSE, PROVIDING A REPEALER CLAUSE AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City has initiated these text amendments to clarify language in the Ketchum Zoning Code and to allow for development in the Commercial Core District that will implement the goals of the Ketchum Comprehensive Plan; and,

WHEREAS, the Planning and Zoning Commission considered these text amendments in a work session on March 24, 2014; and,

WHEREAS, the Planning and Zoning Commission held a public hearing on this matter on May 28, 2014 and unanimously recommended approval to the City Council; and,

WHEREAS, the City Council conducted a first reading and public hearing on May 19, 2014 and second reading June 2, 2014 on this matter in accordance with the provisions of the Ketchum Municipal Code and Idaho Statutes.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO:

<u>SECTION 1.</u> <u>Commercial Core District,</u> <u>Section 17.64.010.C Exceptions</u>, be amended by deleting therefrom the stricken language and adding the underlined language herein below, to wit:

- C. Exceptions: The purpose of an exception is to allow for a degree of design flexibility within the community core district. Exceptions may be allowed only to only the design regulation provisions included in Sections 17. 64.010.L and 17.64.020 of this chapter may be requested by an applicant at the time of during evaluation of the design review application. An exception may be granted by the Planning and Zoning Commission may be granted by the Planning and Zoning Commission of the design review application.">may be granted by the Planning and Zoning Commission of the design review application. An exception may be granted by the Planning and Zoning Commission of the design review application. An exception may be granted by the Planning and Zoning Commission of the design review application.
 - 1. The granting of an exception will <u>not</u> be for <u>detrimental to</u> the public good.
 - 2. The granting of an exception will not be detrimental to the health, safety, or general welfare of persons residing or working in the neighborhood of the proposed use.

- 3. The granting of the exception will not be detrimental or injurious to property or to the general welfare of the city.
- 4. The exception is to architectural design elements and is not an exception to other development standards such as building height, setbacks, floor area ratio; to any use requirements or restrictions; or to any life safety requirement.

<u>SECTION 2.</u> <u>Commercial Core District, Section 17.64.010.H Maximum Floor Area Ratio,</u> be amended by deleting therefrom the stricken language and adding underlined language herein below, to wit:

H. Maximum Floor Area Ratio:

1. Generally: All new buildings and alterations or additions to existing buildings shall be subject to the maximum floor area ratio described as follows:

	Permitted	Community Housing Incentive
Gross FAR	1.0	2.25

- 2. Floor Area Ratio (FAR) Community Housing Incentive: An increased FAR above 1.0 for providing community housing units-may be permitted up to a maximum of 2.25, subject to design review approval and other applicable development processes or standards within this code, and provided that all of the following conditions are met: and in accordance with the following provisions.
- a. Twenty percent (20%) of the total gross floor area of the building, minus any ground floor retail trade, ground floor retail service, ground floor professional service, and ground floor public/semipublic uses, in excess of 1.0 FAR, is deed restricted in perpetuity as community housing unit(s), pursuant to the definition in Section 17.08.020 of this title. Of the gross square footage of community housing required, a fifteen percent (15%) reduction will be allowed as a standard discount from the gross square footage required to determine net livable square footage of the community housing units.
- b. The maximum floor area <u>incentive</u> applies to <u>buildings up to</u> three stories <u>buildings</u> in height. <u>Buildings above three-stories may exceed the 2.25 FAR maximum only in accordance with the pertinent code provisions allowing for a fourth floor (for example, hotels, PUDs and 100% community housing project, etc.). The fourth floor of buildings may exceed the 2.25 FAR maximum. For hotel uses, community housing calculations apply to those all portions of the hotel development except the hotel units, which are addressed pursuant to Employee Housing, 17.64.010.I, Hotel Uses.</u>

- c. Half of the The required community housing units shall be generally targeted for income categoryies 4 and 6, with an average of category 5, and half of the required community housing units shall be within income categories 7 and above, with an average of category 8. The applicant and city may seek the recommendation of the governing housing authority in the determination of an alternative category when the category is proposed as something other than category 4 and the planning and zoning commission may allow such alternative category. This allowance shall be based on need for the category type. The definition of who may qualify to purchase affordable housing shall be maintained in the guidelines of the "governing housing authority Guidelines" as adopted by the city council.
- d. Of the gross square footage of community housing required, a fifteen percent (15%) reduction will be allowed as a standard discount from the gross square footage required to net livable square footage of the community housing units.
- e. For hotel developments, community housing calculations apply to all residential units. However, one hundred percent (100%) of the community housing requirement will be waived only for the residential portion of hotel projects that meet the hotel definition adopted by the Ketchum city council, provided the project obtains a complete building permit prior to June 1, 2012, and so long as the property is maintained appropriately as directed by staff and/or city council.
- fee in lieu for the required community housing square footage. The fee due to the city is calculated based on the total square footage or fraction thereof required multiplied by the adopted in lieu fee. (The in lieu fee is adopted yearly by the City of Ketchum.) If any fraction of community housing requirements may be paid via a fee in lieu of housing, fraction of community housing units times the fee equals the amount due to the city. The fee in lieu shall be recommended by the governing housing authority on an annual basis and adopted by the city council. or working with the city or other nonprofit entity to purchase the balance of the community housing unit with additional funds.
- g.f All community housing units, either for sale or rental, shall be administered by the governing housing authority. All housing that is provided shall meet with the adopted guidelines of the governing housing authority. The governing housing authority shall recommend the types, locations and categories of all proposed community housing units for approval by the city. The city council may approve alternatives to the administration of units at their discretion.
- h.g. The city's <u>primary</u> goal is to <u>see the development of and</u> encourage the construction of <u>whole</u> community housing units, <u>but realizes that other options will also move the city closer to its goal of housing the workforce.</u> and not to create a program for fee in lieu for <u>whole units</u>. However, the city council may consider a request by the property owner to pay a fee in lieu of constructing a complete community housing unit or provide other

considerations as the city council deems appropriate. The city council has full discretionary power to determine said request. With this in mind, the following options for fulfillment of the community housing incentive are available to the applicant outright. These include, but are not limited to:

- 1. Housing constructed by the applicant on or off-site, within the City of Ketchum;
- 2. Payment of an in lieu fee; or
- 3. Acquisition of existing housing stock that meets with the governing housing authority's requirements and approval.
- h. In addition to those outright options noted above in (g), the city council may consider alternative proposals by the applicant to fulfill the community housing incentive. The city council has full discretionary power to determine said request. Options for fulfillment of the community housing incentive include, but are not limited to:
 - 1. Land conveyance to the city;
 - 2. Existing housing unit buy down or mortgage buy down; or
 - 3. Other proposals and options as approved by the city council.
- **SECTION 3. SAVINGS AND SEVERABILITY CLAUSE**. It is hereby declared to be the legislative intent that the provisions and parts of this Ordinance shall be severable. If any paragraph, part, section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid for any reason by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.
- **SECTION 4. CODIFICATION CLAUSE.** The City Clerk is instructed to immediately forward this Ordinance to the codifier of the official municipal code for proper revision of the code.
- **SECTION 5. REPEALER CLAUSE**. All City of Ketchum code sections, ordinances or resolutions or parts thereof, which are in conflict herewith are hereby repealed.
- **SECTION 6. PUBLICATION.** This Ordinance, or a summary thereof in compliance with Section 50-901A, Idaho Code, substantially in the form annexed hereto as Exhibit A, shall be published once in the official newspaper of the City, and shall take effect immediately upon its passage, approval and publication.

- 2. COMMUNICATIONS FROM COUNCILORS and KCDC Board members.

No comments at this time.

3. DISCUSSION OF KETCHUM COMMUNITY DEVELOPMENT CORPORATION'S ROLE REGARDING KETCHUM'S 2014-15 BUDGET OBJECTIVES 5:
RESTRUCTURE ECONOMIC NON-GOVERNMENT
ORGANIZATIONS TO MORE EFFECTIVELY USE
AND COORDINATE RESOURCES.

KCDC President Neil Bradshaw said the KCDC organized this meeting to discuss the FY2015 KCDC budget. Bradshaw would like to schedule a follow-up joint meeting for Ketchum city officials to take the lead in giving the KCDC direction for the upcoming year.

KCDC Executive Director Jon Duval led discussion of the KCDC's FY2015 budget: Income:

- Ketchum Innovation Center (KIC)'s budget is now included in the KCDC budget. KIC rent units are 100% passthrough from tenant to landlord.
- 3% administration fee from Idaho's Bounty.
- Cash flow from Northwood Place decreases as the building ages and expenses increase.

Expenses:

- KCDC office rent was \$440/month in the Starbucks building and is now \$100/month in the KIC building.
- Office supplies/taxes/telecommunications. If Ketchum gets fiber optics, KIC will have to figure out how to pay to install fiber optics in the KIC building. The monthly telecommunications budget line item may increase.

Projects:

- The KCDC and Ketchum Parks have discussed putting in a parcourse and dog park in five-acre Northwood Park. Ketchum Councilor Baird Gourlay suggested the park could also have a mountain bike skills course. The KCDC has budgeted funds. The Board discussed if the KURA could fund the park.
- Ketchum Innovation Center (KIC) ongoing.

The KCDC budget has been flat the last four years. The only increase this time is for KIC. Every dollar the KCDC has received from Ketchum has been substantially leveraged.

Ketchum Interim City Administrator Ray Silver said Ketchum's General Fund is already short. The LOT is coming in lower, so the General Fund will probably have to cover some of the LOT shortcoming. The FY2014-15 budget is challenged, probably due to last summer's Beaver Creek Fire and last winter's lack of snow. Ketchum has money

budgeted for special events, the River Park, Mountain Rides, etc. Silver said the Sun Valley Marketing Alliance has to market Ketchum because people don't know about it.

Ketchum Councilor Gourlay concurred that Ketchum is going to have a tough FY2015 budget. He said the URA and KCDC were founded with the understanding that the URA would be the major funder of the KCDC.

- Board Member Michael David suggested they discuss affordable housing funding with the URA. KCDC Executive Director Jon Duval said the need for housing wasn't going away, and there was an ongoing battle to figure out how to get construction funded. There are two local housing-related organizations—ARCH and BCHA, and funding is split between the KCDC and URA, but each focuses on a niche. ARCH and KCDC focus on development; and the KCDC is focused on Ketchum development. Bradshaw said the KCDC's current focus is on build-to-rent units using tax credits. Duval said the KCDC wanted to develop new affordable housing in Ketchum any way possible, but the only way to fund it currently was tax credits. The KCDC will continue to partner with GMC Development in tax credit funding.
- KCDC Board Member Jim Slanetz asked if KIC tenants could pay for utilities or other expenses.
- Councilor Gourlay asked what information KIC tenants were expected to submit to the KCDC to justify their
 subsidy; and what was expected of KIC tenants who were successful. Duval said they would probably consider
 "success" based on the number of employees. He said they would also ask a tenant who wasn't growing to make room
 for someone else. Bradshaw said the KCDC provided an amenity to Ketchum, and shouldn't be considered a moneymaker. Duval said the only way for KIC to really make money was for the City to own the building.
- Board Member David said a big KIC benefit is a commitment to a younger demographic, particularly to people who grew up here and want to develop a business here.
- KIC has a three-year lease on its building, with an option to extend for three years. KIC can cancel the lease at any
 time, with no penalty.
- KIC now advertises itself mostly through events. Ketchum Director of Planning and Building Joyce Allgaier suggested Ketchum could include information on KIC in Ketchum's newsletter.
- Bradshaw said it should be fairly clear in a year whether KIC is a success or not. Councilor Gourlay said he thought \$3,000 was a worthy investment to bring or keep a young business in the area.

4. ADJOURNMENT.

Councilor Baird Gourlay moved to adjourn at 1:15pm. Councilor Jim Slanetz seconded the motion, and it passed unanimously.

1. The meeting was called to order by Mayor Nina Jonas at 5:39pm.

Communications from Mayor and Councilors

2. Communications from Mayor and Council.

- · Mayor Nina Jonas introduced everyone to the new sound system that will allow for live-streaming video.
- Councilor Baird Gourlay said signage was up on Fourth Street in front of Atkinsons' and the park, and mentions bikes and pedestrians, but the signage isn't clear and isn't in the right location. He suggested signs be on Fourth Street at every intersection, especially where it intersects with Highway 75.
 - Ketchum Director of Planning & Building Joyce Allgaier said the signs went up before staff figured out what their goal was. Staff is working on several ideas, including cross-painting and a bike corral in the public right-of-way.
- Councilor Gourlay said a County Road and Bridge levy brochure outlined what uses were allowed with the cities' share of their levy money. He clarified that most of Ketchum's levy money would be spent on roads that are quickly deteriorating.
- Council President Michael David said the Ketchum Traffic Authority is looking at different strategies to improve safety on Fourth Street for pedestrians, bikes and cars.
- Councilor Anne Corrock suggested Ketchum investigate having a place where RVs passing through town can park for awhile and their people can walk around town and shop.
 Councilor Jim Slanetz suggested Ketchum talk to Sun Valley Company about the River Run parking lot.

3 Swearing in of volunteer firefighters.

Mayor Nina Jonas welcomed and swore in new volunteer firefighters: Kyle Ray, Craig Huettig, Steve Southard, Jasmine Furnish, Brenda Johnson, and Gerad House.

Ketchum Fire Chief Mike Elle said volunteer firefighters have other jobs and families and leave whatever they are doing to help people who need them. He thanked the firefighters for making the commitment.

4. Communications from the Public

- Phyllis Shafran asked when a decision would be made on Fourth Street.
 Council President Michael David said Ketchum needed engineering studies to support anything they did on State Highway 75. He added that making Fourth Street one-way is not an option they're considering.
- Mickey Garcia didn't like that public comment was at the option of the Mayor and Council. He thought it should be
 five minutes instead of three minutes. Garcia said the website was exceptional since Mayor Jonas took office.

Public Hearing

5. Ordinance No. 1117, re Proposed Text Amendments to the Ketchum Zoning Code Title 17, Community Core District, Chapter 17-64010(C) Exceptions, and (H) Maximum Floor Area Ratio.

Ketchum Director of Planning & Building Joyce Allgaier explained the proposed Commercial Core Code Amendments to Council:

- Permit the P&Z some flexibility in Design Review to allow for some exceptions to architectural design elements. This
 does not give P&Z flexibility in defined uses, heights, setbacks, FAR, lot coverage, or anything to do with life-safety or
 community character.
- Revise the provision regarding maximum floor area ratio (FAR); and also increase options for what qualifies as
 providing community housing. The Community Core allows a gross floor area ratio of 1.0 on a lot, up to 2.25 FAR,
 by providing 20% community housing. Because CH must be provided for the first 1.0 FAR and everything over,

developers are building right up to the maximum of 1.0 and not going over so they don't have to provide CH. The proposed text amendment makes the first 1.0 FAR not subject to CH requirement.

- Buildings in the Community Core can be up to three stories tall as long as they meet building height. Hotels and buildings that are 100% community housing can be four stories.
- Community housing priorities are clarified for developers. Community housing needs change, but Income Category 4
 (100% area median income) is the target for developers. The Blaine County Housing Authority will work with
 developers to find the best categories at the time.
- The hotel waiver to community housing that expired in June 2012 is removed.
- Clarify options that developers have for providing community housing.
- Staff and the Housing Authority will review and adopt a new in-lieu fee every January.
- All housing that is provided shall meet with adopted guidelines of the governing housing authority.
- · Council can choose a manager for community housing.
- The Blaine County Housing Authority oversees and updates adopted guidelines, i.e., CC&Rs, HOA fees, etc.

At Council's discretion, a developer can provide community housing by land conveyance to the City, existing housing unit or mortgage buy-down, and other proposals. Ketchum wants to keep its downtown vital with housing and people moving around.

PUBLIC COMMENT:

Mickey Garcia supports the ordinance; but said the average person couldn't understand the English.

Staff will show Councilors examples of FARs from 1.0 to 2.25 at a future meeting.

Councilors comments:

- Councilor Anne Corrock hesitates to accept in-lieu fees for full units, since developers would take in-lieu if they could.
 She said in-lieu should only be taken if a fraction of a unit is required.
- · Councilors said the Code wasn't producing any units now, and should be changed to make it more workable.

Councilor Baird Gourlay moved to approve the first reading of Ordinance 1117, amending Title 17, Chapter 17.64.011 Community Core District, (c) Exceptions, amending language to allow for exceptions to be allowed by the Planning & Zoning Commission in design regulations; and floor area ratio, amending language pertaining to allowable floor area ratios as it relates to the Community Housing Initiative; and schedule a second reading for June 2, 2014. Motion seconded by Council President Michael David, and passed unanimously.

Communications from Staff

6. Update on Live and On-Demand Audio/Video Streaming and Audio Upgrade in Council Chambers Ketchum Assistant to the City Administrator Lisa Enourato described the new system that will provide live streaming video of Ketchum's meetings.

7. Public Comment on Proposed FY14-15 Budget Objectives

Ketchum Interim City Administrator Ray Silver said Ketchum holds workshop every year to draft objectives to guide development of the upcoming fiscal year budget. Council welcomed public input on April 21 and revised the objectives to include "wildlife habitat" and "attract and retain newer and younger generations."

PUBLIC COMMENT:

Aimee Christensen, both personally and as chair of the Ketchum Energy Advisory Committee, encouraged Council to
provide strong leadership in environmental protection and protection of natural assets as the underpinning of quality
of life in the Wood River Valley. When polled, the community's first priority was to value natural assets and
surroundings.

The Ketchum Energy Advisory Committee supports Ketchum in becoming an environmental innovator and leader, and creating local jobs. The Committee requests \$5,000 be set aside for a forum and potential funding of outside experts.

The Ketchum Energy Advisory Committee also suggests \$50,000 be set aside for potential high visibility pilot solar and energy efficiency projects to promote the Sun Valley brand.

Councilor Anne Corrock moved to adopt the Fiscal Year 2014-15 budget objectives as determined by the Mayor and City Council. Motion seconded by Council President Michael David, and passed unanimously.

Agreements and Contracts

8. Right-of-way Encroachment Permit and Agreement, A.W.E. LLC, 460 First Street East

Ketchum Director of Planning & Building Joyce Allgaier said the applicant is requesting a right-of-way encroachment permit for their garage as part of a Development Agreement Rezone application. The project will go before P&Z before it returns to Council. The applicant has obtained a building permit for an interior remodel to turn the building into a professional office. Parts of the garage, a shed and fence are located in Ketchum right-of-way on East and First.

This is an opportunity to remove something from the right-of-way, but the garage is a vestigial piece of Ketchum's history, and property boundaries were not always clear in the old days. But there are problems, and the City Attorney does not recommend the right-of-way permit for ongoing use of the structure in the right-of-way. The intersection of East and First is sometimes busy with drivers avoiding the Main Street intersection. There is no stop sign for drivers on First turning onto East. On East Avenue going south at the First Street intersection, there is a stop sign with additional sign that says, EXCEPT RIGHT TURN, so drivers sometimes corner pretty fast. Cars in the garage will back out onto First, adding to traffic problems at the intersection. The garage also creates a sight impediment for drivers on East Avenue turning onto First.

One side of the garage is where the sidewalk should be. Snow sheds off the garage roof onto the right-of-way.

Matt McNeal, representing the owner, said East Avenue is a dead end. The building is intended to be mixed office and residential. The parking requirement is met by the garage. There is mature landscaping in the rear and an Idaho Power box in the alley. The building is in a small area zoned Tourist and was previously used as a children's art school.

PUBLIC COMMENT:

- Bruce Smith did the survey for a previous owner, but is not involved in this project. East Avenue is a 100-foot-wide dead-end street with two rows of parking in the middle of the street. He thinks it's a cool old building.
- Ian Jamison works with McNeal and would like to be a future tenant of the office part of the building. He's likes
 messy vitality and urged Council to allow the encroachment.
- Jim Ruscitto, adjacent neighbor, doesn't object to keeping a historic structure, but does object to the use of a non-conforming structure providing required parking. Cars in the garage would back out against traffic into the opposite lane in a busy intersection. He urged Council to demand the required off-street parking, and said it could be provided in the alley. The garage can be repaired and used for storage and be a charming element in the neighborhood.
- Elaine French loves the building and makes the right turn every day. It's not a perfect traffic situation, but the building
 is worth preserving.
- Jim Figge agrees the building should be preserved and the right-of-way permit should be granted. He said there are a number of other uses permitted in the area.
- Mickey Garcia agreed with messy vitality and preservation of the building, but felt parking should be required offstreet.

Staff's preference is for the required three parking spaces to be off the alley, although some landscaping would have to be removed.

The applicant would like to keep the garage even if it can't be used to meet their parking requirement.

Councilors' comments:

- Councilor Corrock said cars would be backing onto First Street, and this area would someday have more hotel vehicle and pedestrian traffic. Ketchum needs to get complete sidewalks, and this is a life-safety concern.
- Councilor Gourlay wants to keep the building. He disclosed that McNeal sent him an email about the garage. East
 Avenue is a road to nowhere. The community objected to an underground parking garage under East Avenue, so East
 Avenue is basically a parking lot. He didn't feel a historic building should be destroyed to provide another parking
 spot or two. He would like to see pavers along the east side of the garage to provide connectivity; and felt the garage
 could provide one parking space. Snowclips could help prevent snowslides.
- Councilor David would like to keep the building, but didn't like the idea of vehicles backing out onto First Street. He also felt drivers on East Avenue should stop before turning right.
- Councilor Jim Slanetz said people ride their bikes here. He likes the building, and wouldn't remove it just to provide
 one more parking space.

Director of Planning & Building Joyce Allgaier said Council could discuss use of the garage in the future when they discuss the Development Agreement.

Councilor Anne Corrock said the developer would have to pay to install the sidewalk now if they went forward with the project and removed the garage. If the building remains and sidewalk installation is delayed indefinitely, the city would have to pay for it. Director of Planning & Building Joyce Allgaier said the City could devise some kind of separate agreement or in-lieu for the sidewalk during Development Agreement.

Councilor Baird Gourlay moved to approve the proposed right-of-way encroachment permit application by A.W.E. LLC and authorize the Mayor to sign a right-of-way encroachment permit agreement with said owner. Motion seconded by Councilor Jim Slanetz, and passed with three in favor and Councilor Anne Corrock opposed.

Ordinances and Resolutions

9. Resolution 14-012: Support of designation of the Boulder-White Clouds as a national monument.

City Attorney Stephanie Bonney drafted a Ketchum resolution based on Blaine County's resolution favoring national monument status for the Boulder-White Clouds.

Idaho Conservation League Central Idaho Associate Dani Mazzotta said ICL had been the leading advocate for wilderness designation for the Boulder-White Clouds for nearly three decades. Congress has not passed wilderness status for the area, so ICL is considering Presidentially-proclaimed national monument status for the Boulder-White Clouds. National monument status would remove motorized use out of recommended wilderness area, withdraw the entire area from future mining claims, remove grazing from ecologically-sensitive places, and conserve the future integrity of rivers, fisheries and habitat.

Other national monuments contain areas already designated as national recreation, wilderness and other specially-designated areas. The Boulder-White Clouds area contains the Sawtooth National Recreation Area. Mountain bikers did not join the Central Idaho Economic Development and Recreation Act (CIEDRA) effort, but are cooperating with ICL toward a common goal of balance of wilderness character and access in the Boulder-White Clouds.

Management plans are written after a designation and full public National Environmental Policy Act (NEPA) process. Blaine and Custer County Commissioners and the city of Stanley have drafted a letter to departments of Interior and Agriculture and the White House, inviting them to visit the area and host public meetings in Idaho.

PUBLIC COMMENT:

- Bruce Smith has spent much time in the Boulder-White Clouds on everything from skis to hiking to an airplane. He
 has a problem with the plan being developed after designation when there is already a good plan for the SNRA. He
 didn't think the President should use the Antiquities Act to sidestep Congress. The Antiquities Act states, "the limits
 of which, in all cases, shall be confined to the smallest area compatible ..." The Antiquities Act doesn't include
 anything about economic benefit. Idaho is mixed uses.
- A Ketchum resident said national monument status would put structure over the whole area and keep it like it is. He mountain bikes, four-wheels and skis, and is willing to give up something to keep the entire landscape.
- Claire Casey has lived in Custer and Blaine counties. National monument status under one management plan is
 important for this spectacular area, and can include multiple uses. She would like to see the area continue to be a true
 wilderness experience without mountain bikes, dirt bikes and ATVs that are harming the area. Rivers and creeks
 should be protected to the fullest extent.
- Matt McNeal, Wood River Bicycle Coalition Board member, said the Bike Coalition worked well with several
 conservation organizations to form a plan that represents the best of recreational assets and environmental protection.
- Debra Bohrer agreed with Claire Casey. She is especially concerned about groups who want the state to manage federal lands, which opens up the land to oil and natural gas extraction.
- Julie Richardson is a fly-fisher who is concerned about the watershed and supports the Boulder-White Clouds. She doesn't want the perfect to get in the way of the possible.
- Mickey Garcia, former Custer and now Blaine county resident, worked for the Forest Service and BLM and fought forest fires. He fought the Vietnam War for benefit of the entire United States of America, not just one county.
- Bob Jonas said times change quickly. The Mayor's grandmother grew up in a livestock/mining community—a dying lifestyle—similar to the Lost River Valley from Arco to Challis. Promoting quality of life and wilderness values is in their interest as it is in the Wood River Valley. He believes local leadership can come together and figure out what's best for future generations and land, water and wildlife.
- Elaine French, Chairman of the Board of the Idaho Conservation League, supports national monument designation, which would remove 360,000 acres from potential mining claims and activity. Motorized use increases every year and is decreasing the amount of landscape that is pristine and potentially eligible for possible wilderness designation overlay. Designation could begin to control unauthorized user-created roads.
- Betsy Mizell is a new Ketchum resident who's been coming here for three generations. She supports national
 monument designation and protection for the Boulder-White Clouds for her future family.
- · Aimee Christensen has seen degradation of the area and supports national monument designation.
- Mike Levy, Lake Creek resident, is concerned that Lake Creek and part of Eagle Creek are now included in the map.
 He asked if the Lake Creek ponds would have roads and RVs driving there. He said the Boulder-White Clouds should
 be in the mountains, and not this close to town. Levy said the SNRA was beautiful, and he didn't want to see
 mountain bikes take over.
- John Kelley, Sun Valley resident, favors wilderness protection to the maximum extent possible. National monument status sounds good, but a detailed analysis of the proposal shows it to be flawed and a lot of details don't make sense. His major concern is that it would be a new policy that wouldn't actually add any level of protection or actual management.

Dani Mazzotta answered questions:

- The proposed boundary follows U.S.F.S. recommended wilderness and watershed boundaries, with the East Fork of the Salmon River draining into the Big Wood River drainage.
- The SNRA is a designated wilderness area. Local bike groups will advocate for closure of some trails and access on some trails in the SNRA in a public NEPA process.
- The Obama Administration is very interested in ongoing discussions among stakeholders. It is crucial for local governments to be involved in the process, and Idahoans have a large influence.
- Outfitters and guides' existing permits would not be impacted.

Council comments:

- Councilor Corrock thinks the area should be preserved, but hasn't researched all the different designations and isn't
 ready to made a decision on national monument designation. She doesn't like the economic reference in Ketchum's
 resolution.
- Councilor Jim Slanetz said most people in the area have the same end result goal. He isn't sure if national monument status is best, but feels it is worth the risk.
- Mayor Jonas said she had given a lot of thought to the Boulder-White Clouds. There is a lot of degradation, especially
 in watershed areas that drain into Lake Creek and Eagle Creek. She hopes this designation will get better overall
 management.
- Council President Michael David agrees that benefits to the local economy should be removed from the resolution. He is concerned about future mining claims, and feels Council should take action.
- Councilor Gourlay asked about existing guides and outfitters; and if there would be charges for public use or parking. He asked if CIEDRA was still a possibility.

Mazzotta said outfitters and guides would have to go through the permit process, which isn't easy. Those who have permits are working with ICL to preserve existing permits. The ICS is not a proponent of additional visitor infrastructure and fees, but all national monuments are different and fall under different agencies with different structures. The national monument proclamation includes standard language to withdraw the area from mining (and other forms of resource entry), which threatens the land outside the SNRA.

- Councilor Gourlay has seen degradation caused by grazing and molybdenum mining, and feels the area is worth
 preserving. He supports wilderness values and removing economic benefits from the resolution. He added that he
 didn't want to see parking lots at the end of Lake Creek.
- Bruce Smith said the whole SNRA has been withdrawn from mineral extraction.

Councilor Baird Gourlay moved to adopt Resolution 14-012 expressing to President Obama and the people of the United States qualified support of designation of that region of central Idaho known generally as the Boulder-White Clouds and containing areas of significant scientific, historical and cultural value as a national monument. In discussion, Councilors discussed if the resolution should include collaboration with the names of biking organizations. Councilor Gourlay amended his motion to remove reference to economic benefit in the resolution. Motion seconded by Councilor Jim Slanetz, and passed with three in favor. Councilor Anne Corrock abstained, since she wanted to wait for a clean resolution.

10. Resolution 14-013: Authorizing payment of certain recurring invoices.

Ketchum City Treasurer/Clerk Sandra Cady said Ketchum adopted Resolution 08-091 authorizing the City Treasurer/Clerk to pay certain vendors prior to submitting the bills to City Council for approval. Since that resolution was adopted, some vendors have become obsolete and others have been added. Cady submitted a list of additional vendors.

Councilor Anne Corrock moved to approve Resolution 14-013 authorizing the City Treasurer/Clerk to pay certain vendors prior to submitting the bills to City Council. Motion seconded by Council President Michael David, and passed unanimously.

Ordinance 1116: Amending Title 6.04.0990, Ketchum Municipal Code; as it relates to exotic animals. Third reading and adoption

Also Present: Maya Burrell and Sage School students

This is the scheduled third reading of Ordinance 1116. Councilors requested the language "camels, llamas and bison" be removed.

Councilor Anne Corrock asked the students if they were satisfied with the ordinance that only restricts exotic animals that are part of mobile exhibition. She suggested the term "exotic wildlife" be used consistently throughout the ordinance.

Student Evathea Drougas said they mostly focused on traveling circuses, which confines animals in small cages on the road for long periods of time. Ketchum's current ordinance prohibits animal abuse, but no one is allowed to record evidence of abuse.

PUBLIC COMMENT:

- Maya Burrell congratulated Ketchum for being the first city in Idaho and neighboring states to pass a ban against traveling animal circuses.
- Aimee Christensen said this is one way to show Idaho can lead in important ways and listen to people in the community.
- Mickey Garcia said Council had been misled by this whole issue. Ketchum residents are capable of making their own decision about whether they should go to a circus.

- Students Devon Brown and Kayla Chaffey said elephants have been used by people for thousands of years, but their DNA is wild. The only way to make them obey is to chain them up when they're babies and beat them into submission.
- Brennan Rego asked what it cost Ketchum to process an ordinance like this.

City Attorney Bonney said the students suggested ordinance language, so she spent an hour at most in addition to the time she was at the City Council meetings. Her retainer rate is \$175.00 hour. Acting City Administrator Silver said he wasn't aware of any other staff time spent on this ordinance.

Councilor Anne Corrock said the proposed ordinance said the same thing as Ketchum's current ordinance, but with the addition of the word "circus".

Council President Michael David moved to adopt Ordinance No 1116; amending Title 6.04.090 Ketchum City Code entitled Exotic Wildlife to prohibit traveling circuses and providing an effective date, with amendments discussed. Motion seconded by Councilor Baird Gourlay. Roll call: Councilor Anne Corrock yes, Councilor Jim Slanetz yes, Council President Michael David yes, Councilor Baird Gourlay yes. Motion passed unanimously.

12. CONSENT CALENDAR

Roll call: Councilor Baird Gourlay yes, Council President Michael David yes, Councilwoman Anne Corrock yes, and Councilman Jim Slanetz yes. Motion passed unanimously.

Councilor Baird Gourlay moved to adjourn at 10:15 p.m. Council President Michael David seconded the motion, and it passed unanimously.
