

RESOLUTION NO. 750

SECTION 1. That the proposed budget, setting forth the proposed, probable and estimated expenditures and revenues to be appropriated, and which are necessary for all purposes, within the City of Ketchum, Idaho, for the fiscal year beginning October 1, 2000 and ending September 30, 2001, be and the same is hereby approved and the City Clerk is directed to enter the same into the minutes.

SECTION 2. That public hearing hereon be held at 6:00 P.M. on September 5, 2000 in the City Hall, 480 East Avenue North, Ketchum, Idaho.


