RESOLUTION NO. 790

A RESOLUTION PROCLAIMING A GENERAL CITY ELECTION, TO BE HELD ON NOVEMBER 6, 2001, DESIGNATING THE POLLING PLACE, DESIGNATING THE REGISTRAR AND DEPUTY REGISTRARS, AND ORDERING THE CITY CLERK TO GIVE NOTICE OF SUCH ELECTION.

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF KETCHUM, IDAHO, THAT:

SECTION 1. The general city election will be held in and for the City of Ketchum, on the 6th day of November, 2001, at which time there will be elected a Mayor and two (2) Councilmembers to serve for a term of four years, or until election and qualification of their successors.

SECTION 2. There shall be one polling place for the City of Ketchum, to-wit: The City Hall, 480 East Avenue North.

SECTION 3. That, Marsha Reimann, County Clerk, is hereby designated as Registrar who shall, with the assistance of Joanna Ehrmantraut, Marge Praegitzer, DiAnne Shrumm, Merla Pyne, Jackie Collett, Jolyn Drage, Schar Boyd, Sandra Cady, Patricia Bennett, Kathleen Schwartzenberger and Kathleen Brune, register the electors of said precinct of said City.

SECTION 4. That the following named persons be, and the same hereby are appointed to act as officials at the General City Election to be held in the City of Ketchum, Idaho, on November 6, 2001.

SECTION 5. The Clerk, for and on behalf of the Mayor and Council, shall give public notice of the time and place of holding such general city election by posting such notice in three public places or publishing such notice in at least two issues of the Idaho Mountain Express, a newspaper printed and published in the City of Ketchum, Idaho, the first publication of such notice to be made not less than 45 days previous to the date of such city election and the last publication not less than 15 days prior to the election; the notice so published shall state the date of the election, the polling place, and the hours during which the polls shall be open for the purpose of voting; said notice to contain such information in accordance with the requirements of Section 50-436 of the Idaho Code.
