Edward Simon, Candidate for the Office of Mayor, four year term, received 518 votes, which number of votes is the highest number of votes cast for such Candidate and he is hereby declared to be the duly elected Mayor of the City of Ketchum, Idaho.

Christina Potters, Candidate for the Office of Council Seat No. 2, four year term, received 519 votes, which number of votes carried the required >50% majority of the votes cast for each council seat, and she is hereby declared to be the duly elected Councilwoman of the City of Ketchum, Idaho.

Certificates of Election shall be presented on January 7, 2002 to Edward Simon, as Mayor and to Christina Potters, as Councilwoman - four year term, of the City of Ketchum.

Anne Corrock, Baird Gourlay, and Millie Wiggins, Candidates for the Office of Council Seat No. 1, four year term, require a majority (>50%) of the votes cast for each council seat, (379 + 460 + 193=1032.00) (1/2 of 1032=516). No candidate received a majority of the votes cast for Council Seat No. 1, therefore a Runoff Election will be held between the two (2) candidates, Anne Corrock and Baird Gourlay, having received the highest number of votes cast for Council Seat No. 1.

Such runoff election shall be conducted on the fourth Tuesday following the regular municipal general election and in the same manner thereas, provided however, notice of the runoff election and the sample ballot shall be published by the City Clerk in the official newspaper of the city on the second and third Wednesdays next following the municipal general election.

NOTICE OF RUNOFF ELECTION is hereby given: That the Runoff Election for the City of Ketchum, Idaho, will be held on Tuesday the 4<sup>th</sup> day of December 2001, on which day Polls will be open from 8:00 a.m. to 8:00 p.m. at the designated Polling Place of Ketchum City Hall, 480 East Avenue North for the purpose of election of a Councilmember to serve for a term of four years.
