A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH THE IDAHO TRANSPORTATION DEPARTMENT FOR THE DEVELOPMENT OF TRANSPORTATION PLAN FOR THE CITY OF KETCHUM.

WHEREAS, the Idaho Transportation Department, hereafter called the STATE, has submitted an Agreement stating obligations of the STATE and the CITY OF KETCHUM, hereafter called the CITY, for development of a transportation plan; and

WHEREAS, the STATE can only pay for work associated with the State Highway system; and

WHEREAS, the CITY is fully responsible for its share of project costs; and

NOW, THEREFORE, BE IT RESOLVED:

- That the Agreement for Federal Aid Highway Project STP-0004 (122) is hereby 1. approved.
- 2. That the Mayor and the City Clerk are hereby authorized to execute the Agreement on behalf of the CITY.
- 3. That duly certified copies of the Resolution shall be furnished to the Idaho Transportation Department.
