

RESOLUTION NUMBER 845

A RESOLUTION OF THE CITY OF KETCHUM, IDAHO, ESTABLISHING MONTHLY SEWER USER RATES AND CLASSIFICATION OF SEWER USERS, AND WHEN SEWER USER CHARGES SHALL BE DUE AND PAYABLE.

WHEREAS, it is necessary that the City of Ketchum establish a fee schedule and appropriate charges for the maintenance and operation costs of the municipal sewage treatment and collection system, and for accumulating capital for future improvements, expansions and additions to said system; and,

WHEREAS, it is necessary to establish charges and fees to make the sewage treatment and collection system fair, equitable and self supporting as required by law; and,

WHEREAS, Ketchum Ordinance Number 819 provides that monthly rates for various classifications of sewer users shall be set by Resolution of the Ketchum City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF KETCHUM, IDAHO, AS FOLLOWS:

SECTION 1. SEWER USER CHARGES. That the following monthly rates for various classifications of sewer users shall be, and the same are hereby established:


A single user having more than one classification shall be charged for the sum of all applicable classifications.

All persons sixty-five (65) years of age and older who are assessed a monthly sewer fee for their residence in the City of Ketchum and who are the property owners of said residence upon written application to the City Clerk shall qualify for code 46, the monthly rate for a Senior Citizen Single Family Home.


SECTION 2. USER CHARGES. WHEN DUE AND PAYABLE. That all sewer user charges shall be due and payable to the City Clerk by the 20th day of the month billed and upon failure to pay the same, as prescribed, each user shall pay, in addition to the amount due, a delinquency charge of 10% of the amount due. There will be a Returned Check Charge of \$10.00

SECTION 3. EFFECTIVE DATE. All provisions of this Resolution shall become effective on October 1, 2002.
