
A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO, AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH THE BLAINE COUNTY SENIORS' COUNCIL, INC. FOR THREE THOUSAND FIVE HUNDRED AND NO/100 DOLLARS (\$3,500) FOR THE PROVISION OF NUTRITIONAL ASSISTANCE, EDUCATION, AND OTHER PROFESSIONAL SERVICES TO THE SENIOR CITIZENS OF KETCHUM FOR THE 2002-03 FISCAL YEAR.



NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Ketchum, Idaho:

1. That the City Council of the City of Ketchum hereby finds that said Agreement is in the best interest of said City and the inhabitants thereof in order to protect and promote the public health, safety and welfare; and, that said Agreement is in accordance with and authorized by the laws of the State of Idaho.

2. The City Council of the City of Ketchum, Idaho, hereby authorizes and instructs the Mayor of said City to execute the Agreement with the Blaine County Seniors' Council, Inc. for three thousand five hundred and no/100 dollars (\$3,500) for the provision of nutritional assistance, education, and other professional services to the Senior Citizens of Ketchum for the 2002-03 fiscal year.

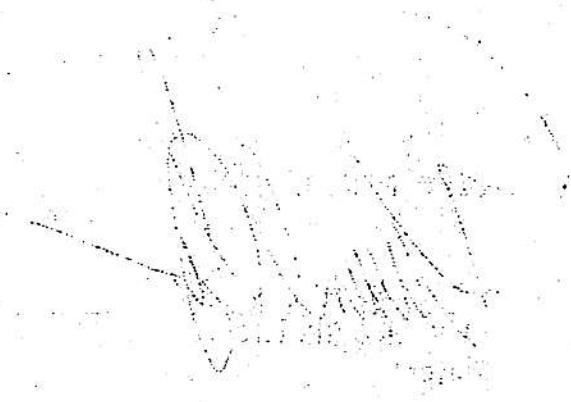
