WHEREAS, the City of Ketchum and the Blaine County Ambulance District have agreed to provide this service through an agreement with the City of Ketchum Fire Department (Attachment A), and

WHEREAS, in consideration of these services, the Blaine County Ambulance District will compensate the City of Ketchum the sum of FIVE HUNDRED AND SIXTY-EIGHT THOUSAND NINE HUNDRED AND TWENTY SEVEN DOLLARS (\$568,927) during fiscal year 2003-2004 payable in installments as outlined in the agreement,

NOW THEREFORE BE IT RESOLVED, that the City Council hereby approves the EMERGENCY MEDICAL SERVICES AGREEMENT with the Blaine County Ambulance District, and that the Mayor be authorized to execute said agreement.
