The City of Ketchum has appointed Jim Spinelli with Wood River Insurance in Hailey as our "Agent of Record" for the liability and property insurance program placed with ICRMP.

The selection is consistent with our new practice of using the Request for Proposal (RFP) process to determine professional services contracts. These RFP's will allow us to maintain an atmosphere of competition that will translate into better service rendered to the City. RFP's will be staggered to facilitate workload of city staff.

The City solicited Requests for Proposals (RFP) for "Agent of Record" from 20 agents and agencies from across the state. All these agents and agencies were pre-qualified through ICRMP.

The City received a total of 11 responses from the following agents and agencies: Alpine Insurance Agency, Inc., Baker Insurance Agency, Inc., Balanced Rock Insurance Agency, Inc., Dahlinger & Co., The Hartwell Corporation, Mutual Insurance Association, Inc., Pioneer Financial Services, L.L.C., Premier Insurance, River Street Insurance, Starley Leavitt Insurance Agency, Inc., and Wood River Insurance, Inc.

Five finalists were interviewed: Wood River Insurance, The Hartwell Corporation, Balanced Rock Insurance, Premier Insurance, and Starley-Leavitt Insurance.

The City's premium cost with ICRMP will not change for this year. The insurance coverages also remain the same. Wood River Insurance will bring a new level of service to this account. Mr. Spinelli and I plan to meet on Monday to map out an approach that takes full advantage of his expertise and services.
