

AGREEMENT EXTENDING THE KETCHUM-SUN VALLEY PUBLIC TRANSIT AUTHORITY AGREEMENT

THIS EXTENSION AGREEMENT is made and entered into this 11+ play of December 2003, by and between the City of Ketchum, Idaho, a political subdivision of the State of Idaho ("Ketchum"), and the City of Sun Valley, Idaho, a political subdivision of the State of Idaho ("Sun Valley").

RECITIALS

WHERAS, the parties hereto entered into an Agreement dated June 5, 1989 (the "Agreement"), pursuant to Idaho Code § 50-322 to purchase, lease or otherwise procure public transit systems, and to provide by general ordinance for the regulations governing the maintenance and operation of the same; and

WHERAS, the parties desire to extend the Agreement pursuant to the provisions of paragraph 6, <u>Duration</u>, of the original Agreement.

NOW, THEREFORE, the parties hereto agree as follows:

- Except as herein expressly provided to the contrary, the Agreement executed by the parties hereto on the 5th day of June, 1989, shall remain in full force and effect.
- 2. The term of commitment set forth in Paragraph 6 of the Agreement shall be extended and continued until 5:00 p.m., December 31, 2006.
- In the event of the formation of a Regional Transportation Authority, or similar agency, then this Agreement may be renegotiated or dissolved by either City giving to the other City a sixty (60) day written notice to renegotiate the terms of the Agreement or dissolve the Agreement.
