WHEREAS, a 4x4 utility vehicle (description attached) was determined to be the best piece of equipment for this purpose and that funds were budgeted for this purpose, and


WHEREAS, the City of Ketchum published a notice inviting bids in the Idaho Mountain Express on November 19 and November 26, 2003, and

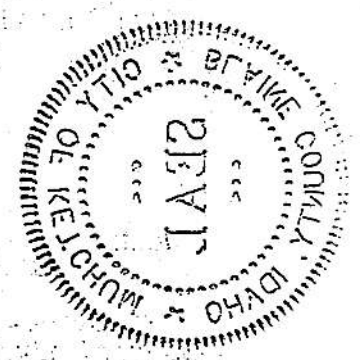
