RESOLUTION NUMBER 04-036

A RESOLUTION OF THE CITY OF KETCHUM, IDAHO, ESTABLISHING FEES FOR PLANNING AND ZONING FUNCTIONS.

WHEREAS, it is hereby found by the City Council that it is necessary to establish fees for reimbursement to the City of the reasonable costs of administration, including notification to adjacent property owners, processing, reviewing and regulating matters of zoning and subdivision, according to Zoning Code Title 17, as amended, Subdivision and Planned Unit Development Ordinance Title 16; and,

WHEREAS, it is hereby found by the City Council that the existing application fees are inadequate and insufficient to cover said administrative costs; and,

WHEREAS, the City Council desires the ability to waive the Planning and Zoning fees for other governmental agencies or for employee or low-cost housing in those cases where the City Council can determine that the waiving of said fees is in the public interest.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Ketchum, Idaho:

- 1. That application fees for Planning and Zoning functions shall be as listed in Exhibit A.
- 2. That the fee for the review, inspection, or any other services performed on a project by the City Engineer shall be in the actual amount as billed by the City Engineer.
- 3. That said application fees shall be paid by the applicant to the Ketchum Planning Department prior to the application being certified by the Planning Department as a complete application.
- 4. That said fees shall be non-refundable unless the proposed project is withdrawn prior to its initial review by the Commission, except for ten (10) percent of the application fee that will be retained by the City of Ketchum to cover the cost of initial administrative processing and review costs of the application and notification.
- 5. That the applicant is responsible for any additional administrative costs of applicable public notices, copies, postage and publication of legal notices.
- 6. That the Planning Director shall waive such fees upon direction from the City Council for employee or community housing or any other application where the Council determines it is in the public interest to waive said fees.

- 7. That should any section, subsection, paragraph, sentence, clause or fee or any particular application thereof be declared invalid by a Court of competent jurisdiction, such designs shall not affect the remaining provisions and fees established by this Resolution.
- 8. That this Resolution of the City of Ketchum hereby repeals in their entirety Resolution Number 624, Resolution Number 716 and all other resolutions in conflict herewith.
- 9. That the provisions of this Resolution shall be in full force and effect from and after the date of approval.


