RESOLUTION NUMBER 04-038

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO, AMENDING RESOLUTION NUMBER 747 BY INCREASING FEES FOR THE USE OF THE FOREST SERVICE PARK AND ADDING THE ROTARY PARK AND ATKINSON'S PARK IN KETCHUM, IDAHO TO THE SPECIAL EVENT FEE SCHEDULE.

WHEREAS, it is necessary that the City of Ketchum establish a fee schedule for appropriate charges to persons and organizations that use the Forest Service Park for Special Events;

WHEREAS, the City finds that the existing fees are inadequate to cover the cost of services provided and increased fees are therefore required;

WHEREAS, such fees collected are to be used to reimburse the City for additional grounds maintenance costs caused by the Special Event at the Forest Service Park; and,

WHEREAS, certain categories of events should be exempt from charging fees for the use of the Forest Service Park either because they:

- a. only use a small portion of the Park and, therefore, are not classified as a Special Event, or
- b. The Special Event is open to the public where no entry fee is charged and/or the Special Event is a fundraiser for a non-profit community based organization and such Special Events are in the public interest and should be encouraged by the City of Ketchum.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Ketchum, Idaho that Resolution Number 747, establishing fees for the use of the Forest Service Park in Ketchum, Idaho, is hereby amended, altered, and changed to read as follows:

- 1. No fee for small gatherings such as small weddings or birthday parties where only a portion of the Forest Service Park is used and the event is not classified as a Special Event under Ordinance Number 669, as amended. Fees may apply for the above uses at Rotary Park or Atkinson's Park under Resolution Number 03-035.
- 2. No fee is charged should the Special Event be a fundraiser for a non-profit community based organization.
- 3. For all other Special Events using the Forest Service Park, Rotary Park and Atkinson's Park, the fee to be charged is \$250 for the first day of the event and \$100 per day for additional days of the same event within the same calendar year.

The applicable fee for the use of the Forest Service Park, Rotary Park and Atkinson's Park for a Special Event shall be paid to the City prior to the issuance of the Special Event Permit as provided by Ketchum Ordinance Number 669.

BE IT FURTHER RESOLVED that all fees and charges established herein shall become effective on the effective date of this Resolution.


