RESOLUTION NUMBER 04-042

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO, APPROVING THE CO-SPONSORSHIP OF FOUR CONCERT SERIES WITH BRAVO ENTERTAINMENT AT THE PARK AND RIDE LOT.

WHEREAS, the City of Ketchum has the opportunity to co-sponsor a series of four concerts on the City Park and Ride Lot property to provide recreational and cultural opportunities to the citizens of Ketchum;

WHEREAS, the City Park and Ride Lot is zoned General Residential – Low Density (GR-L) Zone;

WHEREAS, cultural and recreational uses are allowed as a conditional use in the General Residential – Low Density (GR-L) Zone;

WHEREAS, the City of Ketchum has a Conditional Use Permit, Number 91-003, that allows temporary recreational and cultural uses approved by the City Council;

WHEREAS, pursuant to Chapter 12.32, the City of Ketchum requires a Special Event Permit for the proposed concerts in order to evaluate traffic, police and fire protection;

WHEREAS, Bravo Entertainment and the City of Ketchum have submitted a Special Event Permit to the Planning and Zoning Department for consideration and approval;

WHEREAS, a portion of the proceeds from the ticket sales and other revenue will go toward the improvements for the Guy Coles Skate Park;

WHEREAS, the City finds that in addition to the cultural and recreational benefit to the public, as well as the benefit provided to the above organization, the concert series will also provide an economic benefit to the citizens and businesses in the City of Ketchum; and,

WHEREAS, the City will receive option tax revenue from ticket sales, concessions and tourist accommodations.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Ketchum, Idaho:

- The City Council of the City of Ketchum, Idaho, hereby authorizes the cosponsorship of a series of four concerts to be held in the summer of 2004 at the City Park and Ride Lot property pursuant to the Special Event Permit approved by Staff and the City Council in accordance with this resolution; and,
- 2. The City Council instructs the Mayor of said City to execute an Agreement with Bravo Entertainment in a form acceptable to the Ketchum City Attorney setting forth the terms and conditions of the co-sponsorship. Said agreement shall include, but not be limited to, the indemnification of the City of Ketchum for the concert series.
