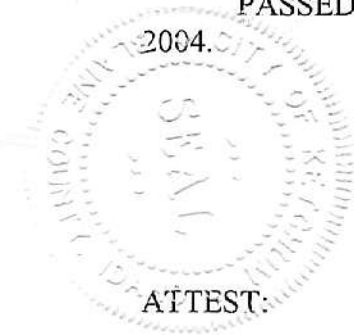
WHEREAS, the main purpose of the regulations of Chapter 15.12 Development Impact Fee, of the Ketchum Municipal Code is to prescribe the procedure by which developers of land shall pay an impact fee as set forth in the chapter for the purpose of providing the public facilities and system improvements needed to serve future residents and users of such development.

WHEREAS, Chapter 15.12, Section 15.12.020, Definitions, defines "Fee Administrator" as the official or designee appointed by the mayor with city council approval to administer this chapter.

WHEREAS, it is the desire of the Mayor to appoint Ronald LeBlanc as the Fee Administrator for the City of Ketchum.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the City Council of Ketchum, Idaho that Ronald LeBlanc is hereby appointed and approved to serve as the Fee Administrator for the purpose of administering the City of Ketchum's Development Impact Fee Ordinance.
