WHEREAS, it is the desire of the Mayor to appoint Ronald LeBlanc as the Fee Administrator for the City of Ketchum.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the City Council of Ketchum, Idaho that Ronald LeBlanc is hereby appointed and approved to serve as the Fee Administrator for the purpose of administering the City of Ketchum's Development Impact Fee Ordinance.


