RESOLUTION NUMBER 05-009

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO AUTHORIZING THE MAYOR TO EXECUTE AGREEMENTS WITH TWELVE SEPARATE INDEPENDENT CONTRACTORS TO PERFORM AND COMPLETE SNOW REMOVAL SERVICES FOR THE CITY, AND REPEAL RESOLUTION NUMBER 04-087 IN ITS ENTIRETY.

WHEREAS, the Ketchum City Council previously approved Resolution No. 04-087 authorizing the Mayor to execute nine independent contractor agreements for snow removal services on November 1, 2004; and

WHEREAS, of such nine independent contractors, names of companies have changed, others have incorporated, and three more contractors have been added; and

WHEREAS, it is in the best interest of the City of Ketchum to repeal Resolution No. 04-087 and replace the same with this resolution; and

WHEREAS, it is the policy for the Ketchum Street Department to maintain the city streets in as safe a condition as possible during the winter months, depending upon available budget, manpower and equipment; and

WHEREAS, the City desires to employ the twelve separate independent contractors to perform and complete snow removal work for the City.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Ketchum, Idaho:

- 1. That the City Council of the City of Ketchum hereby finds that such Agreements are in the best interest of said City and the inhabitants thereof in order to protect and promote the public health, safety and welfare; and
- 2. That such Agreements are in accordance with and authorized by laws of the State of Idaho; and
 - 3. That Resolution No. 04-084 be repealed in its entirety; and
- 4. The City Council of the City of Ketchum, Idaho, hereby authorizes and instructs the Mayor of said City to execute Independent Contractor Snow Hauling Agreements for the winter months of 2004-2005, terminating May 1, 2005, with the following Contractors:
