**RESOLUTION OF THE CITY OF KETCHUM CITY COUNCIL  
AUTHORIZING CO-SPONSORSHIP OF THE 2005 BRAVO SUMMER  
CONCERT SERIES AT THE PARK AND RIDE SITE AND DIRECTS THE  
PLANNING DIRECTOR TO PROCESS THE SPECIAL EVENT PERMIT**

**WHEREAS, the City of Ketchum agrees to co-sponsor with Bravo Entertainment, the Summer Concert Series at the Park and Ride lot for the third consecutive year, and**

**WHEREAS, the Park and Ride lot is zoned General Residential - Low Density (GR-L), which allows cultural and recreational uses as a conditional use in that zone, and**

**WHEREAS, the City Council issued Condition Use Permit, Number 91-003, that allows temporary recreational and cultural uses as approved by the City Council, and**

**WHEREAS, pursuant to Chapter 12.32 of the Ketchum City Code, a Special Event Permit must be issued for these concerts, and that as a requirement of the Special Event Permit, traffic, police, fire and ambulance protection must be evaluated, and**

**WHEREAS, Bravo Entertainment is required to submit to the Planning Department, a Special Event Permit listing the City of Ketchum as a co-sponsor, for consideration and approval by the Planning Director, and**

**WHEREAS, at the request of the City, Bravo Entertainment has worked with local organizations to minimize potential conflicts in scheduling, and**

**WHEREAS, Bravo Entertainment is proposing four concerts on the following dates: July 2, August 14, August 30 and September 10, and**

**WHEREAS, the City recognizes these dates are subject to change based upon availability of the performing artists and that the artists mentioned at the Council meeting are also subject to change, and**

**WHEREAS, as in previous years, a portion of the ticket sales from two concerts and parking revenue from all concerts, will be earmarked for the Guy Coles Skate Park, and**


WHEREAS, a portion of the proceeds from the ticket sales from one concert will be earmarked for the Ski Education Foundation, and

WHEREAS, proceeds from ticket sales at the Willie Nelson concert will be earmarked for a special children's fund in conjunction with the anticipated visit by His Holiness, the Dalai Lama, and

WHEREAS, the City recognizes the economic benefit that this concert series brings to the local economy,


NOW THEREFORE BE IT RESOLVED, that the Ketchum City Council authorizes co-sponsorship of the 2005 Summer Concert Series with Bravo Entertainment, and directs the Planning Director to process the special event permit.
