RESOLUTION NUMBER 05-047

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO, AUTHORIZING THE MAYOR TO EXECUTE A SETTLEMENT AGREEMENT BETWEEN THE CITY AND CATHERINE G. FISCHER ET AL. RESOLVING ALL ATTORNEY FEES AND COSTS AWARDED IN FISCHER ET AL. V. CITY OF KETCHUM, IDAHO SUPREME COURT DOCKET NO. 29469; AND AUTHORIZING A PAYMENT TO CATHERINE G. FISCHER ET AL. IN SETTLEMENT OF SUCH AWARDS IN THE AMOUNT OF \$28,000.

WHEREAS, Catherine G. Fischer and other plaintiffs (collectively "Fischer") initiated a judicial review proceeding relative to a City zoning decision and appeal to City Council regarding such decision on or about June 21, 2002 (the "Judicial Review"), by filing a Petition for Judicial Review in the District Court of the Fifth Judicial District of the State of Idaho, in and for the County of Blaine (Case No. CV-02-08563), naming the City as Respondent; and

WHEREAS, upon Judicial Review, the District Court upheld the City Council's decision; and

WHEREAS, Fischer appealed the matter to the Idaho Supreme Court as Docket No. 29469; and

WHEREAS, the Idaho Supreme Court reversed the decision of the City Council, remanded the matter to the Planning and Zoning Commission for further proceedings and awarded Fischer attorney fees pursuant to I.C. § 12-117; and

WHEREAS, a good faith dispute arose between Fischer and the City regarding the actual amount such award; and

WHEREAS, Fischer and the City have agreed to settle such dispute in full by entering a Settlement Agreement pursuant to which the City shall pay Fischer \$28,000 (TWENTY-EIGHT THOUSAND DOLLARS).

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Ketchum, Idaho, that the City Council hereby authorizes the Mayor to execute a Settlement Agreement between the City and Catherine G. Fischer *et al.* resolving all attorney fees and costs awarded in <u>Fischer *et al.* v. City of Ketchum</u>, Idaho Supreme Court Docket No. 29469; and authorizing a payment to Catherine G. Fischer *et al.* in settlement of such awards in the amount of \$28,000.


