And, a notice for said election having been duly signed by the City Clerk of said City, and having been thereafter published in the Idaho Mountain Express, Ketchum, Idaho, in the manner provided by law; and

WHEREAS, the judge of election has made her return of said election and the same have been found to be in proper form, and,

Randy Hall, Candidate for the Office of Mayor, four-year term, received 503 votes, which number of votes is the highest number of votes cast for such Candidate and he is hereby declared to be the duly elected Mayor of the City of Ketchum, Idaho.


Baird S. Gourlay, Candidate for the Office of Councilmember, four-year term, received 698 votes, which number of votes is the highest number of votes cast for such Candidate, and he is hereby declared to be the duly elected Councilmember of the City of Ketchum, Idaho.

Ron Parsons, Candidate for the Office of Councilmember, four-year term, received 628 votes, which number of votes is the next highest number of votes cast for such Candidate, and he is hereby declared to be the duly elected Councilmember of the City of Ketchum, Idaho.

Certificates of Election shall be presented on January 3, 2005 to Randy Hall, as Mayor, Baird S. Gourlay and Ron Parsons, as Councilmembers – four-year term, of the City of Ketchum, Idaho.


