WHEREAS, the Police Department included funds in the FY2006 Budget for the replacement of a vehicle used by the Community Service Officers, and


WHEREAS, in addition to consulting the available vehicles through the State of Idaho, "State Bid" listing, bids were solicited from local dealers, and

This Resolution will be in full force and effect upon its adoption this third (3rd) day of January, 2006.





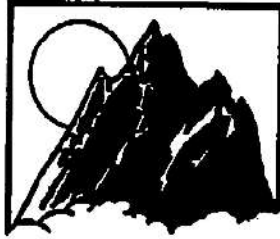
