A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO, CONFIRMING THE MAYOR'S APPOINTMENT OF MICHAEL ROOS TO SEAT NO. 3 ON THE BOARD OF COMMISSIONERS OF THE BLAINE-KETCHUM HOUSING AUTHORITY FOR A FOUR-YEAR TERM EXPIRING FEBRUARY 1, 2010.

WHEREAS, pursuant to Idaho Code § 67-2328, the City of Ketchum entered into a Joint Powers Agreement with Blaine County, forming the Blaine-Ketchum Housing Authority (BKHA) and setting forth the process by which commissioners shall be appointed to the Board; and

WHEREAS, Seat No. 3 for which the commissioner is appointed by the Mayor of Ketchum is currently vacant; and

WHEREAS, Michael Roos is highly qualified to fill such position and has expressed his interest in becoming a commissioner of the BKHA Board; and

WHEREAS, pursuant to the Joint Powers Agreement, said selections for commissioner appointment shall be made by the Mayor of Ketchum, with confirmation of the Ketchum City Council.

NOW THEREFORE, BE IT RESOLVED, the Mayor's appointment of Michael Roos to Seat No. 3 on the Board of Commissioners of the Blaine-Ketchum Housing Authority for a four-year term expiring February 1, 2010 is confirmed.
