A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO APPOINTING MEMBERS TO THE DEPARTMENT OF BUILDING SAFETY BOARD OF APPEALS, PURSUANT TO ORDINANCE NUMBER 979, AND ESTABLISHING COMPENSATION FOR SUCH MEMBERS.

WHEREAS, pursuant to Ordinance Number 979, the Board of Appeals shall consist of five individuals (two (2) registered design professionals with architectural experience or a builder or superintendent of building construction with at least ten years' experience, five of which shall have been in responsible charge of work, one (1) registered design professional with structural engineering experience, one (1) registered design professional with mechanical and plumbing engineering experience or a mechanical contractor with at least ten years' experience, five of which shall have been in responsible charge of work, and one (1) registered design professional with fire protection engineering experience or a fire protection contractor with at least ten years' experience, five of which shall have been in responsible charge of work); and

WHEREAS, the City desires to appoint Woody Bryant as one of the registered design professionals with architectural experience or a builder or superintendent of building construction with at least ten years' experience, five of which shall have been in responsible charge of work, for a period of five (5) years; and

WHEREAS, the City desires to appoint Peter Ripsom as one of the registered design professionals with architectural experience or a builder or superintendent of building construction with at least ten years' experience, five of which shall have been in responsible charge of work, for a period of three (3) years; and

WHEREAS, the City desires to appoint Scott Heiner as the registered design professional with structural engineering experience for a period of four (4) years; and

WHEREAS, the City desires to appoint Joe Humphrey as the registered design professional with mechanical and plumbing engineering experience or a mechanical contractor with at least ten years' experience, five of which shall have been in responsible charge of work, for a period of one (1) year; and

WHEREAS, the City desires to appoint Jerry L. O'Neal as the registered design professional with fire protection engineering experience or a fire protection contractor with at least ten years' experience, five of which shall have been in responsible charge of work, for a period of two (2) years; and

WHEREAS, the City desires to appoint Jack Smith, FAIA; Thad Blanton, AIA; Buffalo Rixon, AIA; Dave Wilson; and Matt Morrell, P.E as alternate members to the Board of Appeals for a period of five (5) years each; and

WHEREAS, the five members hearing an appeal shall receive \$150 each per meeting for compensation for their services.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Ketchum, Idaho appointing members to the Department of Building Safety Board of Appeals, pursuant to Ordinance 979, and establishing compensation for such members.
