RESOLUTION NO. 06-119

A RESOLUTION OF THE CITY OF KETCHUM AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT AGREEMENT FOR SERVICES WITH BLAINE COUNTY TO CONDUCT THE SPECIAL ELECTION FOR THE GENERAL OBLIGATION BOND ISSUE.

WHEREAS, the City of Ketchum, Blaine County, Idaho (the "City"), has determined to conduct a special bond election on November 7, 2006, on the question of authorizing the City to issue its general obligation bonds in the principal amount \$1,550,000 for the purpose of financing the costs of acquisition of snow removal equipment, and costs incidental thereto, and

WHEREAS, Ketchum is a municipal corporation duly organized and existing under the laws of the State of Idaho, and

WHEREAS, Blaine County is a political subdivision of the state of Idaho duly organized and existing under the laws of the State of Idaho, and

WHEREAS, pursuant to Idaho Code §§§ 50-301, 50-302, and 50-303, Ketchum has the authority to enter into contract agreements and to take such steps as are reasonably necessary to maintain the peace, good government, and welfare of the City and its trade, commerce, and industry; and

WHEREAS, Blaine County is highly skilled and is experienced in providing election staff and services, and

WHEREAS, Blaine County is holding their General Election also on November 7, 2006, which constitutes 4 precincts in Ketchum. The City of Ketchum only having the one precinct, desires to hold the City's election jointly with Blaine County to provide better service to the citizens of the City of Ketchum, and

WHEREAS, Ketchum desires to contract with Blaine County for election services to provide staffing, equipment and materials, and

WHEREAS, Blaine County agrees to pay the election staffers at the 4 precincts located in Ketchum with the exception of the City of Ketchum counting clerks.

WHEREAS, Blaine County desires to contract with Ketchum to provide said staff, equipment and materials with the understanding that the City of Ketchum will provide meals for the election staff at the 4 precincts located in Ketchum.

NOW THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Ketchum, Idaho, that the City Council hereby authorizes the Mayor to execute a Contract Agreement for Services with Blaine County to conduct the Special Election for the General Obligation Bond Issue.

This Resolution will be in full force and effect upon its adoption this 16th day of October 2006.


