

RESOLUTION NUMBER 07-015

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO ACCEPTING BIDS FOR A REPLACEMENT LOADER AND AUTHORIZING THE MAYOR TO AWARD THE BID TO WESTERN STATES FOR \$200,000

WHEREAS, the voters of Ketchum overwhelmingly approved a General Obligation Bond in the amount of \$1,500,000 on November 7, 2006, and

WHEREAS, the purpose of this bond issue was to finance snow removal equipment, including two new blowers, a grader and a loader, and

WHEREAS, bid specifications were developed and advertised for a used Caterpillar Model 966G II wheel loader, or the equivalent, and in excellent condition, and

WHEREAS, two bids were received from:

- Western States Caterpillar \$200,000
- Burks Tractor \$220,798


WHEREAS, the two bids were for used equipment, the low bid is the better value and is recommended by the Street Superintendent, and

WHEREAS, the low bid from Western States Caterpillar is for a Caterpillar model 966G II wheel loader, stock number G8805, serial number OAXJ02591, model year 2005, with low hours of operation and an extended warranty,

NOW THEREFORE BE IT RESOLVED, that the Ketchum City Council accepts the bids for a replacement loader and authorizes the Mayor to award the bid to Western States Caterpillar for \$200,000.



This Resolution will be in full force and effect upon its adoption this 16th day of January, 2007.


