

RESOLUTION NUMBER 07-024

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO, CONSENTING TO THE ASSIGNMENT OF ALL RIGHTS AND OBLIGATIONS OF HEATHER LA MONICA DECKARD ESTABLISHED IN THAT CERTAIN CONTRACT FOR SERVICES DATED DECEMBER 11, 2006 BETWEEN THE CITY OF KETCHUM AND HEATHER LA MONICA DECKARD FOR THE PRODUCTION OF THE 2007 WAGON DAYS EVENT TO SUN VALLEY EVENTS, INC., AN IDAHO CORPORATION.

WHEREAS, pursuant to Resolution 06-120, the City of Ketchum entered an agreement with Heather LaMonica Deckard on December 11, 2006, for professional services to promote, organize, manage, coordinate and produce the 2007 Ketchum Wagon Days event (the "Contract"); and

WHEREAS, Heather LaMonica Deckard has ceased doing business as an individual and now conducts all business through Sun Valley Events, Inc., an Idaho corporation; and


WHEREAS, Heather LaMonica Deckard has requested that the City consent to an assignment of her rights and obligations in that Contract from herself as an individual to Sun Valley Events, Inc.; and


WHEREAS, Paragraph No. 10 of the Contract allows for such an assignment only with the City of Ketchum's prior written consent.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Ketchum, Idaho, that the City Council hereby consents to the assignment of all rights and obligations of Heather La Monica Deckard established in that certain contract for services dated December 11, 2006 between the City of Ketchum and Heather La Monica Deckard for the production of the 2007 Wagon Days Event to Sun Valley Events, Inc., an Idaho corporation.

This Resolution will be in full force and effect upon its adoption this twentieth (20th) day of February 2007.


