WHEREAS, the City of Ketchum desires to enter into such contract with Delta Dental to provide such services.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Ketchum, Idaho that the City Council hereby authorizes and instructs the Mayor to execute contract with Delta Dental for dental benefits provided to employees of the City of Ketchum.
