A RESOLUTION OF THE KETCHUM CITY COUNCIL AWARDING A CONTRACT FOR LONG DISTANCE TELEPHONE SERVICES TO QWEST AND AUTHORIZES THE MAYOR TO SIGN THE CONTRACT

WHEREAS, the City of Ketchum will save an estimated \$262.00 per month by switching to Quest, for an annual savings of \$3,144;

NOW, THEREFORE, BE IT RESOLVED by Ketchum City Council that the City of Ketchum awards a contract with Quest for long distance telephone and that the Mayor is authorized to sign the agreement.



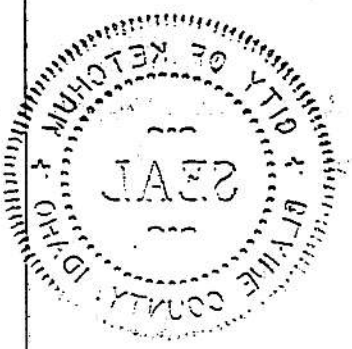
