A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO
AUTHORIZING THE MAYOR TO EXECUTE A FSA PLAN SERVICE
AGREEMENT WITH NATIONAL BENEFIT SERVICES, LLC TO PROVIDE
SERVICES FOR THE CITY OF KETCHUM CAFETERIA PLAN IN AN AMOUNT
NOT TO EXCEED \$2.00 PER MONTH PER EMPLOYEE ON INSURANCE, PLUS
\$75.00 PER PLAN AMENDMENT.

WHEREAS, pursuant to Idaho Code §50-301, the City of Ketchum is empowered to enter into contracts as may be deemed necessary to promote the public health, safety, and welfare of Ketchum and its residents; and


WHEREAS, the City desires to obtain services associated with preparing and maintaining the City of Ketchum Cafeteria Plan, as well as all other administration services required for such Cafeteria Plan; and

WHEREAS, National Benefit Services, LLC has such expertise and has offered to provide such services in an amount not to exceed \$2.00 per month per employee on insurance, plus \$75.00 per plan amendment.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Ketchum, Idaho that the Mayor is authorized and directed to execute a FSA Plan Service Agreement with National Benefit Services, LLC to provide services for the City of Ketchum Cafeteria Plan in an amount not to exceed \$2.00 per month per employee on insurance, plus \$75.00 per plan amendment.


This Resolution will be in full force and effect upon its adoption this twenty-sixth (26th) day of June, 2007.
