WHEREAS, the City received proposals from three (3) accounting firms/accountants and conducted interviews with each, and

WHEREAS, Rudd & Company, PLLC submitted a proposal that met the needs of the City, demonstrated experience with municipal clients, and a successful track record of providing quality auditing services.

NOW THEREFORE BE IT RESOLVED, that the Ketchum City Council approves the selection of Rudd & Company, PLLC for auditing services, and authorizes the Mayor to execute the contract in an amount not to exceed \$15,360 for the 1st year and an option to extend the contract for an additional 2 years.
