

RESOLUTION NO. 08-012

A RESOLUTION OF THE CITY OF KETCHUM APPROVING THE PURCHASE OF A SEMI-TRACTOR TRUCK FROM NORTHWEST EQUIPMENT SALES, INC. FOR \$37,500.

WHEREAS, on December 21, 2007, one of the wastewater treatment tanker trucks was severely damaged in an accident, and

WHEREAS, a claim was filed with ICRMP, with the adjuster determining that the truck is a total loss, but the tanker trailer is repairable, and

WHEREAS, Utilities Manager, Steve Hansen, performed an extensive search for a used vehicle and recommends the purchase from Northwest Equipment Sales, Inc., and

WHEREAS, a suitable semi-tractor truck has been located at Northwest Equipment, Inc. in Twin Falls and tested to replace the wrecked vehicle, and


WHEREAS, pursuant to Idaho Code 67-2806(1)(e), the City of Ketchum hereby determines that it is impractical to obtain three (3) bids because the City needs the truck immediately in order to safeguard the public health by keeping the waste treatment plant fully operational and further the City hereby deems Steve Hansen's diligent search as the best manner of acquiring the truck under the circumstances; and

WHEREAS, the City shall document a description of the efforts undertaken to procure at least three bids and shall maintain the same for at least six months after the procurement is completed.

NOW THEREFORE BE IT RESOLVED, that the Ketchum City Council approves the purchase of a semi-tractor truck from Northwest Equipment Sales, Inc. at a cost of \$37,500.


This Resolution will be in full force and effect upon its adoption this twenty-second (22nd) day of January, 2008.


