

**RESOLUTION NUMBER 08-068**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO, AUTHORIZING AND INSTRUCTING THE MAYOR TO EXECUTE A SOUTH CENTRAL EMS MUTUAL AID AGREEMENT WITH REGIONAL EMS PROVIDERS.**

WHEREAS, in the interest of conserving resources and protecting and promoting the public health, safety and welfare, certain emergency medical services require the Parties to cooperate with each other, share resources and assist each other by responding within each other's jurisdictions; and

WHEREAS, Idaho Code Section 67-2328 authorizes the parties to collaborate in this manner by entering an agreement for the joint exercise of powers; and

WHEREAS, each of the parties satisfies the requirements set forth in Idaho Code Sections 67-2327 and 67-2328 which provide for public agencies to enter such an agreement; and

WHEREAS, each of the parties has appropriate equipment and trained personnel necessary to provide such services; and

WHEREAS, the City Council of the City of Ketchum hereby finds that a South Central Idaho EMS Mutual Aid Agreement is necessary to conserve resources and to protect and promote the public health, safety and welfare of the inhabitants of the City of Ketchum.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Ketchum, Idaho, that the Mayor is hereby authorized and instructed to execute a SOUTH CENTRAL IDAHO EMS MUTUAL AID AGREEMENT with the CAMAS COUNTY AMBULANCE; CASSIA REGIONAL MEDICAL CENTER (d.b.a. IHC Health Services, Inc.), GOODING COUNTY EMS, KETCHUM FIRE DEPARTMENT, MAGIC VALLEY PARAMEDICS, LLC; MINIDOKA MEMORIAL HOSPITAL (d.b.a. Emergency Response Ambulance), DIVINE MEDICAL SERVICES (dba Jerome County Paramedics), HAILEY FIRE DEPARTMENT, RAFT RIVER FIRE PROTECTION DISTRICT, WOOD RIVER FIRE & RESCUE, AND LINCOLN COUNTY EMS.

This Resolution will be in full force and effect upon its adoption this 2<sup>nd</sup> day of June 2008.


